Did you know...

The abortion industry is pushing one of the most extreme abortion laws in the country in Ohio today?

If passed, their Constitutional amendment would lock legalized abortion through all nine months of a pregnancy into Ohio's Constitution. As a constitutional amendment, Issue 1 would:

- 1) Allow abortionists to perform abortions on children without their parent's knowledge or consent.
- 2) Eliminate Ohio's laws requiring abortion clinics to follow the same health and safety standards as other surgical healthcare facilities.
- 3) Allow abortionists to perform painful-late term abortions through all nine months of a pregnancy.

In other words, Ohio's current common-sense laws regulating abortion will be thrown out because they will be said to, in some way, "directly or indirectly burden" the ability to have an abortion.

Additionally, because this would amend the state Constitution, no laws that clash with it could be enacted in the future, either.
