Hardware store

- Ace is the Place
- We have excellent one now.
- Ace hardware is already close by, let's save the space for more diversity of types of businesses.
- Grand Street as Ace Hardware. Not permitted in town center aka near city hall
- Hours of operation, parking requirements, noise levels, is use appropriate for the surrounding residential neighborhood.
- I have had terrible experiences with the city being unresponsive to legitimate complaints about 5:00 AM deliveries at the Ace Hardware store. These deliveries on Thursday mornings went on for years at 5:00 AM with hammering, pallets being dropped off tractor trailers, tractor trailers idling, and what sounded like a diesel powered fork lift with no muffler. The PPD and city were very obtuse about how there was no enforceable ordinance for the Ace while it would be a nuisance for me to operate a lawnmower at 5:00 AM. Finally, a lawyer told me to ask for the CUP. Every business should be permitted, and the city should ensure that every business toes the line and is a good neighbor. The deliveries now start at 7:00 AM, but every other aspect of the Ace CUP has been disregarded- Ace employees are supposed to park on Linda Ave but have typically parked all day in the green spots... The CUP shouldn't be aspirational or written perfunctorially, it should be promissory and enforced without city planners and city council people saying, "Well, they live in Zone D, what do they expect?" Yes, this was said! I and my neighbors had also had a terrible experience with the Shell Gas Station/repair shop which was granted CUP approval for 6:00 AM to 10:00 PM hours; this was problematic because the city contended that the Shell never needed a CUP until 2008, but there were documents referencing a 1990 CUP, and I could not find any documentation that the neighbors of the Shell had ever had any opportunity to provide input on the hours of operation for that business. We need CUPs, and we need accountability that fosters and maintains public trust and the harmony that Piedmont aspires to maintain in Zone D between residents and business owners. A business owner should not receive unofficial latitude by city officials because they pay more taxes than nearby residents.

 Each of these things would, I hope, be taken into account and limitations applied if needed.

hardware store, specifically, I will note that a hardware store is already located quite nearby on Grand Ave, so this might be of the least utility, in my opinion.

These deliveries on Thursday mornings went on for years at 5:00 AM with hammering, pallets being dropped off tractor trailers, tractor trailers idling, and what sounded like a diesel powered fork lift with no muffler. The PPD and city were very obtuse about how there was no enforceable ordinance for the Ace while it would be a nuisance for me to operate a lawnmower at 5:00 AM. Finally, a lawyer told me to ask for the CUP. Every business should be permitted, and the city should ensure that every business toes the line and is a good neighbor. The deliveries now start at 7:00 AM, but every other aspect of the Ace CUP has been disregarded- Ace employees are supposed to park on Linda Ave but have typically parked all day in the green spots... The CUP shouldn't be aspirational or written perfunctorially, it should be promissory and enforced without city planners and city council people saying, "Well, they live in Zone D, what do they expect?" Yes, this was said! I and my neighbors had also had a terrible experience with the Shell Gas Station/repair shop which was granted CUP approval for 6:00 AM to 10:00 PM hours; this was problematic because the city contended that the Shell never needed a CUP until 2008, but there were documents referencing a 1990 CUP, and I could not find any documentation that the neighbors of the Shell had ever had any opportunity to provide input on the hours of operation for that business. We need CUPs, and we need accountability that fosters and maintains public trust and the harmony that Piedmont aspires to maintain in Zone D between residents and business owners. A business owner should not receive unofficial latitude by city officials because they pay more taxes than nearby residents.

All of the above should be included and more - some have yet to be "labeled".
