# Applied Community Project (ACP) Proposal Development

This resource document provides participants with the information needed to develop Applied Community Project (ACP) Proposal and Presentation.

# **Objectives**

Members of the Learning Lab Cohort will be able to:

- Learn skills and tools to create grant proposals for an ACP that describes how to equitably address an identified community issue through an equity lens.
- Integrate principles of racial and health equity into all elements of the ACP, including developing personal, institutional, and structural-level approaches to equity.
- Receive guidance and technical support to apply knowledge in creating new ACPs or expand existing projects that support local change efforts.
- Develop long term relationships and collaborations with peers to advance next steps and strategies.

## **Vision**

Learning Lab vision for Applied Community Projects:

The ACP is an opportunity for participants to apply racial justice and equity concepts to real-life scenarios and practice using such concepts in collaboration with partners for the development of innovative and scalable community-level health equity projects. Projects should aim to explicitly confront health inequities that are exacerbated by structural racism, class oppression, gender discrimination, and the power and wealth imbalances through policy, system, or environmental changes for a specific community.

Each Learning Lab team is asked to create a proposal for an ACP that would utilize learnings from the MPHI ADJUST (Advancing Justice Together) training curriculum to address systemic barriers and social inequities that impact Black, Indigenous and People of Color's (BIPOC) opportunity to attain their full health potential. Participants will work in their teams to develop an ACP proposal and present their project to a forum of funders in May 2023 (tentative) during the Learning Lab's final meeting.

### The Vision and Desired Outcome:

- What tangible outputs/outcomes will the project create during the 12-month implementation period?
- What high-level impact does the proposed project aim to achieve?
- How will the team measure the project's success?

## Potential Funding Amount: \$25,000

- Teams should develop an ACP idea, proposal, and budget for projects in the amount of \$25,000.
- Teams will have the opportunity to share their ACP proposal presentations during the Funders Forum for the opportunity to have their projects funded for implementation.
- Consideration: Many of you shared your preliminary thoughts for your team's ACP. Some funders are cautious about funding policy work (slippery slope when you get into advocacy and lobbying is usually always off the table), but funding decisions will be made based on what your teams are proposing to do. The biggest feedback we can offer is to be clear about the issue and the proposed solution. The clearer you can be on the problem, the proposed approach, and how you will measure success will increase the likelihood of your project being funded.
