Certain select Pennsylvania State Senators' being the said an Amicus Curiae in support of their authority as a legislative body under the U.S. Constitution, and respectfully urge for favor of Court to file the accompanying motion brief in support of certain plaintiffs and defendants, and instead order this Court to affirm the grant of authority to state legislatures, and not courts, under the U.S. Constitution's Commerce Clause.

This brief will be signed as Amicus Curiae since that the Pennsylvania Senate, together with the Pennsylvania House of Representatives, comprises the General Assembly of the Commonwealth of Pennsylvania. The General Assembly, as the Legislature of Pennsylvania, is given authority to prescribe the "Times, Places, and Manner of holding elections" under Article I, § 4, of the U.S. Constitution.

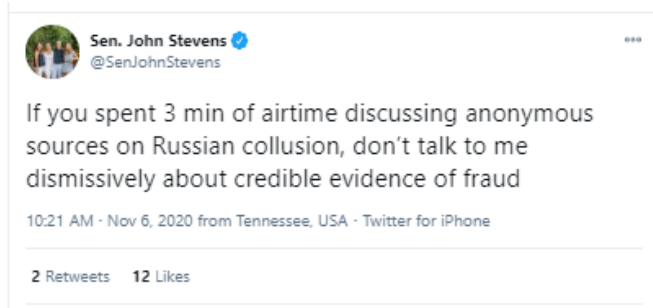

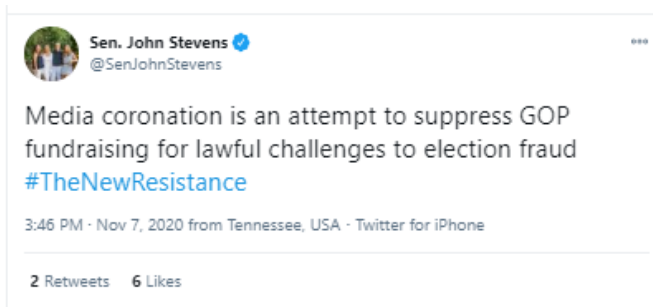

1. What are you doing to ensure the integrity of our elections and the vote counting process right now?
2. Will you continue to use all the resources at your disposal to ensure that only legal votes are being counted?
3. What are you doing to ensure that local election officials are complying with orders from federal and state courts pertaining to the transparency of the vote counting process?
