



# Terms & Conditions

## **\*\*General Information:\*\***

- The Calligraphy Collective 2024 (hereinafter referred to as "the Event") is a calligraphy-focused event organised by [Organiser Name].
- By purchasing a ticket or attending the Event, the attendee (hereinafter referred to as "the Attendee") agrees to comply with these Terms and Conditions.

## **\*\*Agenda:\*\***

- The Event agenda is subject to change without notice at the discretion of the organisers.
- The organisers reserve the right to modify, cancel, or reschedule any part of the Event, including sessions, workshops, speakers, or activities, without prior notice to the Attendee.
- The organisers will make reasonable efforts to inform Attendees about any significant changes to the Event agenda via the official event website or email communication.

## **\*\*Ticket Purchase and Cancellation:\*\***

- Attendees may purchase tickets for the Event through the designated ticketing platform.
- All ticket sales are final, and no refunds or exchanges will be issued, except as provided in Clause 4 (Event Cancellation or Postponement).
- The Attendee is responsible for providing accurate information during the ticket purchase process, including contact details.
- Reselling of tickets for the Event is strictly prohibited.

## **\*\*Event Cancellation or Postponement:\*\***

- In the event that the organisers cancel the Event, the Attendee may be eligible for a refund, subject to the organiser's discretion.
- If the Event is postponed to a later date, tickets will be valid for the rescheduled date, and no refunds will be issued.
- The organisers will not be responsible for any costs incurred by the Attendee due to the Event cancellation or postponement, such as travel or accommodation expenses.

## **\*\*Attendee Conduct:\*\***

- The Attendee is expected to behave in a respectful and appropriate manner throughout the Event.

b. Any disruptive, offensive, or illegal behaviour by the Attendee may result in immediate expulsion from the Event without refund.

c. The Attendee is responsible for any damages caused to the Event venue, equipment, or materials due to their negligence or misconduct.

## **\*\*Intellectual Property:\*\***

- The organisers and/or their partners may record or photograph the Event for promotional or documentation purposes.
- By attending the Event, the Attendee grants the organisers the right to use their likeness, image, or voice in any promotional materials without compensation.

## **\*\*Liability:\*\***

- The organisers will not be held liable for any loss, damage, injury, or expense incurred by the Attendee during the Event, except in cases of gross negligence or wilful misconduct.
- The Attendee acknowledges that they participate in the Event at their own risk and should take appropriate precautions for their personal safety and belongings.

## **\*\*Privacy:\*\***

- The organisers will collect and process personal information provided by the Attendee in accordance with applicable data protection laws and their Privacy Policy.
- The Attendee's personal information may be shared with third parties involved in the organisation and execution of the Event, solely for the purpose of facilitating the Attendee's participation.

## **\*\*Governing Law and Jurisdiction:\*\***

- These Terms and Conditions shall be governed by and construed in accordance with the laws of England and Wales.
- Any disputes arising from or related to the Event or these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of England and Wales.

## **\*\*Severability:\*\***

- If any provision of these Terms and Conditions is found to be invalid or unenforceable, the remaining provisions shall continue to be valid and enforceable.
