I am aware of the conditions of the Site, know that it is my responsibility to observe those conditions before I engage in any Activities, and know that the Activities may include exposure to extreme conditions and circumstances, contact with other participants, boats, manmade objects, and natural objects, adverse weather and water conditions, imperfect ski course and equipment conditions, equipment failures, and risks which are unforeseen or unknown. I represent and warrant that I am in proper physical condition to participate in the Activities, and I agree to be solely responsible for my own safety and well-being at all times and under all circumstances, and I assume the risk of property damage, personal injury or death at all times when I am engaged in any Activities and/or on the Site.
- 3. The Parties. This Agreement is intended to benefit the Owner and its principals, all boat and vehicle owners, and all other Activity participants and/or persons using or on the Site, specifically including third-parties (collectively the "Benefitted Parties"). The Benefitted Parties are intended third-party beneficiaries of this Agreement, and are entitled to enforce the terms of this Agreement.
- 4. Scope of the Agreement. This Agreement is intended to include all Activities of any kind or nature that may occur on the Site. I understand that the risks covered by this Agreement can be caused by my own acts or omissions, or by the negligence, actions or omissions of others, and it is my intent that Agreement inure to the benefit of all of the Benefitted Parties, either directly as Owner or as third-party beneficiaries of this Agreement, and even if the claim arose in whole or in part due to the negligence, actions or omissions of one or more Benefitted Parties.
- 5. Releases and Obligations. In signing this Agreement, I contract and agree to (i) release, waive and covenant not to sue any Owner or other Benefitted Parties relating to any claim relating to any Activity occurring on or relating to the Site, including claims arising as a result of any alleged negligence, action or omission of myself or others; and (ii) indemnify, defend and hold the Owners and Benefitted Parties harmless from any such claim(s).
