Who We Are

<u>Choice in Health Clinic provides compassionate and client-centered abortion care to women</u> and gender-diverse people. We are leaders in accessible, high-quality abortion care provided through an anti-oppression model. We have excellent client satisfaction rates and a happy and engaged interprofessional staff team. The clinic is a registered non-profit and charitable organization and has an annual operating budget of \$1.6 million. The team includes 12 regular and 12 relief staff, a physician rotation, and a small management team.

Who You Are

You are an effective and visionary leader, pro-choice and passionate about advancing reproductive justice. You bring experience with non-profit governance and charity management, including fundraising. Emotionally intelligent, adaptable, and a skilled manager, you have excellent problem-solving skills. You are capable with financial management, knowledgeable about leveraging social media, and comfortable being a spokesperson and advocate.


- Strategic planning and risk management skills.

The Role and What We Offer

The role

- Provide leadership for management of service delivery systems, programming, financial, personnel and public relations at Choice in Health Clinic (CIHC).
- Align operations with CIHC's statement of values, purpose, objectives, and policies, and external regulatory and accreditation bodies (including the College of Physicians and Surgeons of Ontario, the Ministry of Health, and the National Abortion Federation).
- Apply risk management and compliance strategies across financial, human resources, legal and clinical spheres.
- Manage financial resources of CIHC in compliance with policies and legal requirements, (e.g., annual budgeting, monitoring financial records, overseeing administration of benefits)
- Work with the Quality Advisor/Medical Director to ensure quality of clinical care and compliance with the Out of Hospital Premises Inspection Program, Independent Health Facilities Act and the National Abortion Federation.
- Serve as the formal liaison and contact person for community organizations, agencies, professionals, government officials and the media.
- Lead communications strategy, including social media and blog posting.
- Address client feedback proactively and in line with organizational values.
- Report to the Board of Directors and support the Board to fulfil the organization's mission through risk management and strategic planning.
- Initiate and deliver fundraising strategies to support the Access Fund.
- Ensure the security of clinic staff and clients and other visitors and act as liaison with law enforcement and justice officials.

What we offer
