Requirements:

- 1. All work shown must be the vendor's own, original work and must be personally exhibited. Work made from kits or purchased for sale are not permitted.
- 2. Please include 3 photographs of your original art for jurying purposes (unless you were here last year and have the same type of artwork).
- 3. Applications may be mailed or turned in to the Greater Livingston County Arts Council Art Center at 209 W. Madison St., Pontiac, IL 61764.
- 4. Booth spaces are 10 X 10 areas. If two spaces are needed, each space will rent for \$75 (\$75 each if you are a GLCAC member) or \$100 (\$100 if a nonmember). Indoor spaces are limited and will be assigned as applications arrive.
- 5. Exhibitors are responsible for setting up, attending, and taking down their own booths. GLCAC is not responsible for loss or theft of merchandise.
- 6. It is strongly suggested that each artist bring a white tent, or at least an attractive tent and bring all chairs, tables, and other props needed for display.
- 7. Time: Saturday: starts at 9:00 a.m. and ends: 4:00 p.m. Sunday: starts at 9:00 a.m. and ends: 3:00 p.m.
