# Electronic Posting Update - Land Access Interim Committee



The Natural Resources Committee met remotely on June 19, 2020, to review the progress the Information Technology Department (ITD) and the North Dakota Game and Fish Department had made for landowners to electronically post land in the three selected pilot counties (Richland, Ramsey, and Slope). The landowner app. was fully developed and ready for use. The Committee agreed to go forward with the pilot making it available on the NDGF Department's web site. The Committee agreed on a July 15, 2020 deadline for landowners, in the pilot counties, to electronically post their land. As of July 15th deadline, 75 landowners electronically posted 260 tracts. Hunters will be able to access electronically posted lands via smartphone apps current-

ly located on the NDGF website.

The two wildlife community representatives worked with the North Dakota Wildlife Federation to develop a Pilot Program Awareness leaflet that was sent to the ag groups asking them to forward to their members in the pilot counties. The information leaflet was specifically worded to encourage landowners that normally post their land to give electronic posting a try. Our goal is not to see more land posted, but landowners, that already post, use the app to electronically post. The app allows landowners to provide contact information and alternative contacts if they turned access permission over to a tenant. Landowner name or contact name will be required as physical posting is now. Telephone number and other contact information is optional.

The next committee meeting has been tentatively scheduled for August 24. At this time, the plan is to hold an in per-

son meeting with the option for members to join remotely. The concern going forward is to get an agreement within the committee on legislation for the 2021 session. We want to be proactive with a recommendation from the committee that does not include automatic posting. The best case scenario is the have the electronic posting option available in all counties for two more years. At this time, it appears to be the only workable compromise to automatic posting.

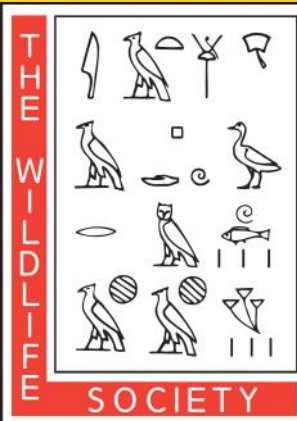

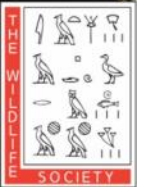

Kimberlee Blevins is one of 5 UTTC students currently participating in a virtual data science program (NSF Earth Data Science Corps), through a collaboration with Earth Lab at the University of Colorado Boulder. The program is focused on helping students gain data science skills, such as: coding in Python, reproducible data analysis, and team collaboration to give them a competitive skill set in the current data-driven job market. Kim is participating in weekly trainings and will be doing an internship project where she will directly apply the skills she has learned to a real-world topic such as helping build health data infrastructure for tribal nations and assess flooding on tribal lands.

Madison Feulner is a junior at North Dakota State University studying Biological Sciences. Madison is the current NDSU Student Chapter President of The Wildlife Society. Currently, she is assisting on a project looking at amphibian bioacoustics. This project seeks to observe the effectiveness of using bioacoustic programs, like Kaleidoscope, to test for presence/absence of different amphibian species. If these programs can successfully detect amphibian calls, this would provide a more cost-effective way for understanding the amphibian biodiversity of an area. Her role in the project is to identify amphibian calls, from collected sound files, that can then be used to form a cluster. The cluster will act as a reference database the program will use when identifying species from thousands of recordings that it receives.

Cailey Isaacson is a junior at the University of North Dakota studying Fisheries and Wildlife Biology. Cailey is the current president of the UND Student Chapter of The Wildlife Society. As an undergraduate researcher, she has the opportunity to work, in collaboration, with Dr. Susan Ellis-Felege and Ducks Unlimited researching waterfowl nesting behavior using nest cameras. As part of this research, she locates duck nests via chain dragging, monitors nests, watches nest footage, conducts wetland surveys, and helps communicate research by posting on the Real Duck Tails social media platform. She is also assisting UND graduate student, Mason Ryckman, in the field with his research on nesting hen behavioral responses to drones.



Gunnar Patz is a senior at the University of North Dakota studying Fisheries and Wildlife Biology with a minor in Communications. Gunnar is the secretary of the UND Student Chapter of The Wildlife Society. He is currently working on a project that is surveying the opinions of stakeholders around the Greenway in Grand Forks. With urban deer populations on the rise, deer related accidents and nuisance complaints rise as well. This project aims to understand how people feel about the growing urban deer population and what steps should be taken to manage it. This fall he will be conducting deer count surveys to estimate how many deer are living in the Greenway. After both surveys are completed Gunnar along with NDGF, Greenway Technical Committee, City of Grand Forks, GF PD, and UND Staff will work to determine the next best steps forward.

Emma Chistensen is a junior at North Dakota State University studying Biological Sciences. Emma is currently working under Ph.D. candidate Heather Smith in collaboration with NDSU and the USDA. Her researcher focuses on agrochemical impacts on the reproductive physiology of *Apis mellifera* drones, including behavior and navigation. Agrochemicals can act as inadvertent contraceptives among bees, affecting multiple reproductive mechanisms in the male, resulting in lowered sperm count, sperm motility, and viability. Navigation and behavior are also a large part of their reproductive success because they mate in congregation areas away from the mother hive.

Adele Malone is a senior at North Dakota State University double majoring in biology and microbiology. Adele started working in Dr. Kendra Greenlee's lab in junction with the USDA in the fall of 2018 and has been lucky enough to be a part of several different projects. Through assisting grad students and working on her own projects, she has been able to focus on a variety of topics from insulin signaling gene expression and adult emergence timing in alfalfa leaf cutter bees. Her current project is looking at known cryoprotectant concentrations in alfalfa leaf cutting bees that are put through different methods of extended cold storage, which have been studied by Dr. Greenlee herself. They hope to learn more about extended cold storage, cryoprotectant levels roles and repercussions, and the relationship between the two in the scope of alfalfa leaf cutter bees, a staple pollinator for our region's crops and natural flora.

### USFS Travel Management Plan Letter (BHA)

- Curt is working on a letter to submit to the USFS about a travel management plan.
  - Curt will try to get a draft out to the board to review so a final letter can be submitted by early next week (6/22/2020).

### Executive Director Discussions

- The board had discussions with Roger Krueger (Great Plains Benefit Group, Employer Advisors) on creating an ED position.
