# **SWOI** Public meeting

It was standing room only as more than 80 residents attended SWOI's AGM and public meeting in Rusper village hall on 14th September,

The first of three guest speakers was **Henry Smith MP** who ran through the reasons why the development was not viable – the unique character and heritage of the area, the impact on biodiversity and the unsustainable pressure on infrastructure such as roads, health services, public transport and water resources.

"This area has taken its fair share of new housing. Local people should not be called NIMBYs for pointing this out."




Henry explained that government policy is that brownfield sites should be developed – not greenfield – and that there is in fact plenty of brownfield land in the south-east.

Henry will deliver his petitions against the West of Ifield development to Parliament in October or November, and he encouraged the campaign not to give up:

"The Homes England plans can be defeated"

The next speaker was **Simon Collins of the River Mole Watch group**. Simon explained the likely impacts of further development on water resources in the area and on the Mole further downstream. Crawley is in the Upper Mole catchment and due to the surrounding hills and clay soil is a 'wet spot' (WSCC

classification) and a

increasing flood risk due to climate change. Any increase in flood risk, sewage overflows or other pollution will all adversely affect areas downstream in Surrey. The Mole is already a stressed river, with nine major sewage works discharging into it and for much of its length running through urban areas. Urbanising one of the remaining rural sections threatens the whole river still further.

The final speaker was **Alison Cornell, West Sussex County Councillor,** who spoke about the horrendous impact of the plans on road layout and traffic volumes across a wide area. Homes England may claim that people will walk or cycle rather than use their cars – the so-called 15-minute neighbourhood – but there is no evidence at all that this might happen. In fact there will be thousands of additional car journeys a day, many rat-running through the small roads of Rusper and Crawley.

Alison also noted the lack of any sensible regional planning process, and the fact that Crawley residents have no formal voice in the planning process despite being most affected by the development.

Questions and points from the floor covered a wide range of topics, and Fenella Maitland-



Smith (SWOI Chair) summed up "The level of support for the campaign and the strength of the arguments we heard from our speakers is all very positive. As Henry Smith said, the Homes England proposals can be defeated. And given what we've heard they certainly should be, and we'll be fighting hard over the coming months."

In their reviews of the past 12 months Fenella and Cathy Durrant (SWOI Treasurer) thanked all those who had helped the campaign, and set out the future challenges and need for funding. ## So what now?

We expect the new Horsham Local Plan to be published by the end of this year, but we must all fight NOW to persuade Horsham Council NOT to include the West of Ifield. Horsham and the Planning Inspector will take the number of objections into account – Rookwood site was initially proposed as a more suitable location than West of Ifield, but was dropped because so many objections were received.

If we don't all act now the door is open for Homes England and their planning application will zoom in on winged feet.

So what should we all be doing?
