Comes now Affiant, _____, one of the people (as seen in the Pennsylvania Constitution Declaration of Rights Section 2), Sui Juris, in this Court of Record, bring the following claims and facts, that you and your agents may provide due care:

Please take note that the Pennsylvania State Constitution, which you have already sworn to, explains that the People have the right to alter, reform or abolish their government in such manner as they may think proper. It is the will of the Affiant to give notice of the true law set forth by the people.

DECLARATION OF RIGHTS

That the general, great and essential principles of liberty and free government may be recognized and unalterably established, WE DECLARE THAT -

Inherent Rights of Mankind

Section 1.

All men are born equally free and independent, and have certain inherent and inalienable rights, among which are those of enjoying and defending life and liberty, of acquiring, possessing and protecting property and reputation, and of pursuing their own happiness.

Political Powers

Section 2.

All power is inherent in the people, and all free governments are founded on their authority and instituted for their peace, safety and happiness. For the advancement of these ends they have at all times an inalienable and inalienable right to alter, reform or abolish their government in such manner as they may think proper.

Right of Petition

Section 20.

The citizens have a right in a peaceable manner to assemble together for their common good, and to apply to those invested with the powers of government for redress of grievances or other proper purposes by petition, address or remonstrance.

Please take notice, ALL power is inherent in THE PEOPLE. ALL free governments are founded on THEIR (the People's) authority. That government is instituted for THEIR (the People's) peace, safety, and happiness. THE PEOPLE have at ALL times an inalienable and inalienable right to alter, reform, or ABOLISH their government in such manner as THEY (the People) may think proper. THE PEOPLE have the right to petition, address or remonstrate. Therefore, ALL officers of government, whether legislative or executive, are their trustees and servants, and at all time accountable to them (the PEOPLE).

Please take further notice, that government is instituted for the common benefit, protection and security of the PEOPLE.

It is therefore hereby the will of the Affiant, to ORDER AND DEMAND that a full forensic audit be done by independent, third party organizations in the SAME manner as the state of Arizona. This full forensic audit should be done immediately in Beaver County, Butler County, Allegheny County, Lancaster County, Dauphin County, Lycoming County, Centre County, Montgomery County, Bucks County, Delaware County and Philadelphia County to ensure accuracy and integrity to Pennsylvania's elections. This is the right of the people who create and regulate the Pennsylvania government. The audit shall be a full forensic audit of ALL paper ballots, NONE excluded. This would apply to ALL in person paper ballots, ALL mailed ballots, ALL military ballots and ALL other paper ballots. This audit will also include a full forensic audit of the machines, software, digital ballots, routers, internet devices as well as any other election related materials and systems. This audit will include scanning all of the ballots, a full manual recount, auditing of the registration and votes cast, the vote counts, and any electronic voting systems used. The specific scope of audit is to be written by Col. Waldron to ensure expertise. The audit itself is to be completed by Cyber Ninjas, CyFIR LLC, Wake Technology Services Inc, Digital Discovery, and Citizens Oversight. Two companies that may NOT be used are Pro V&V and SLI Compliance. The audit shall make provision for Democrat, Republican, Independent and any other party's ability to witness the audit. Results of the audit shall be made available to the public. Affiant, as one of the people, does acknowledge the House of Representatives vote of 120 for and 90 against a "risk-limiting" audit in Nov 2020. However, the audit was not completed. The only option now is to complete the audit as the people wish. By continuing to ignore the will of the people you may be considered as having trespassed against the people. The Affidavit is a Contract, and if you shall ignore this Affidavit by not responding by the following terms, you agree to pay \$1,000 per day if you shall fail to immediately make provisions for an audit. If you, as a government official, believe these claims to be false, please respond within 5 business days with Constitutional Provisions, sworn under penalty of perjury, by Affidavit, point by point, showing where you have the CONSTITUTIONAL authority to ignore these rights of the people. If you do not respond within 5 business days, you agree, by acquiescence, that you are knowingly interfering with the rights of one of the people you swore to protect and that this Affidavit shall stand as evidence that you are acting in MALADMINISTRATION and that NO court shall have the power to again adjudicate these matters and that all Courts of Record shall accept this Affidavit as truth and law. You also agree to be bound by all said herein and the Affiant is able to bring this contract before an arbitrator of Affiant's choice and you agree to be bound by any award.

Notice of this Affidavit, and all information herein, shall be shared immediately with the entire Pennsylvania House of Representatives and the Pennsylvania State Senate.
