Anyone without an actual diploma can purchase one on Amazon (or a number of other sites, google it!). One satisfied customer said, "My son got the job he wanted. It looks so real." To which came this inquiry, "Does this really look like the real thing? I've received an offer for a new job, and they're asking for a copy of my diploma, which I don't have, and I would hate to give two

weeks' notice to my current employer, and for

this not to work."

What is an employer to do when a market designed to provide gag gifts or duplicates of actual diplomas is used for nefarious purposes?
