RECORD EXPUNGEMENT

Considering how complex it is for eligible people to obtain an expungement from the court, what would you do to help simplify and streamline this process?

I have made everyone within my current office task specific. I will pledge to you that I will dedicate someone in my office to streamline the process and to reach out to those eligible for an expungement to insure that they know this is available to them. I don't believe that old nonviolent charges should hinder someone's future prospects because of a mistake that was made in the past. Also, an expungement should be affordable. I will seek out grants and to partner with non-profit organizations to provide funds for people who seek an expungement but can't afford it.







COVID-19 PRECAUTIONS AND POLICY

Do you believe the CDC has the pandemic under control in the building? If not, what procedures or changes would you implement to make it a safer place for the people?



I would ask that all employees be vaccinated and to provide as much protection as possible. I would make vaccines available to all who would want them and to make sure that all litigants have access to a vaccine before entering the building. But I believe that education is the best tool that we have against this virus. As I currently do, I encourage my staff not to come into work if they are not feeling well however since a lot of the new cases are asymptomatic, I believe that quick response testing should be on site. The building needs to be cleansed on a daily basis.

The Clerk of Court has several collections agents. Considering the economic crisis of the COVID-19 pandemic, does the court now, or can you foresee in the future, a moratorium (or forgiveness) on collecting fines and fees of the court?



My current office has been the epicenter for the rental moratorium set up through the CDC. Our citizens have been negatively impacted by the pandemic in multiple ways. I have been an outspoken critic of fee increases and I have even dropped certain fees in my office. I believe that certain fees should not increase or there should be a roll back of these fees and that for those who are in need, the debt should be forgiven.
