### **A Humane Approach to Justice**

#### **Bail Reform**

Bail bonds are used as a way to ensure people show up for future court dates, or risk losing the bond money they posted for bail. Bonds are also used in lieu of costly pretrial detention, and allow people to maintain their jobs, homes, and families. Roughly half of people detained in jails are ineligible for bail due to a probation or parole “hold” or accusation of domestic violence.

**Non-Unanimous Juries**

Three years after 64% of Louisiana residents voted to end non-unanimous jury convictions, and six months after the U.S. Supreme Court found them unconstitutional, nearly 1,500 people convicted by non-unanimous juries remain incarcerated in our state's prisons; many of them until they die.

### **Alternatives to incarceration**

When individuals who have mental illnesses, substance use disorders, and/or are homeless are incarcerated, studies show their conditions are exacerbated. Oftentimes these individuals are released worse off than when they were initially incarcerated.

### **Housing Discrimination**

Louisiana reports over 1.5 million people have criminal records. People who are working and capable of paying rent are routinely denied in their applications to rent an apartment. They are also asked to pay \$25-\$50 for background checks, without being told what is the landlord's criteria for discrimination.

### **Government and Elections**

People in Louisiana who are on probation do not lose their voting rights upon conviction, and people on parole have them suspended only until they are off parole or during the first 5 years of their parole (whichever happens first). However, there is still considerable confusion amongst voters, local Registrars, OMV workers, and probation/parole officers, as to who is disenfranchised and what they need to do to restore their right to vote.

Additionally, the absentee ballot process is difficult to navigate, requiring someone to send an official form requesting a ballot from the registrar where they are registered, and then mailing the ballot back to the registrar in time. They also need certification from the sheriff that they are detained, yet there is no official form. Finally, newly registered people are prohibited from casting their first vote absentee.
