

Q1 Which of the following do you think Greenville County officials should focus on the most to help you and your family? (Rank from greatest to least, with the first being MOST important)





## Q3 Do you support the county's Historic & Natural Resources Trust using your local tax dollars to help expand and create new state parks in Greenville County?





### Q4 Do you support the county trust using your local tax dollars to create new County parks?











# Q8 Which of the following would you support, if proposed, to help fund more rapid protection of open spaces in our fast-growing county?






