

**2022 UAW International Officer Election**  
**Multiple Slate Affiliation Declaration Form**  
**[Election Rules, Section 6-3]**

This Multiple Slate Affiliation Declaration Form accompanies the Slate Declaration Form and is intended for Candidates who seek to affiliate with more than one Slate in the 2022 UAW International Officer Election. All Candidates desiring to affiliate with more than one Slate **MUST** use this form to attest and evidence that they have provided notice and received written consent from each member of each Slate with which they plan to associate. Please read the Explanation and Instructions below. Then, turn to Page 3 to complete the Declaration of Affiliation with Multiple Slates.

**EXPLANATION AND INSTRUCTIONS**

**Explanation**

As set forth in Section 6 of the Official Rules for the 2022 International Officer Election of the UAW (the “Rules”), each Bona Fide Candidate for International Office shall have the right to seek nomination, be nominated, campaign, and appear on the ballot as a member of a Slate of Candidates.

A Candidate may associate themselves with more than one Slate, but they must provide notice that they intend to appear on multiple Slates and receive written consent from each member of each Slate with which they plan to associate that they agree the Candidate can do so. By signing the below Declaration, a Candidate associating with more than one Slate **must** attest to having provided such notice, and receiving such written consent. **The Candidate must also attach and submit documentation evidencing the written consent of each Slate member with the Declaration.**

Any Candidate joining more than one Slate must provide the below Declaration **and required supporting evidence** to the Monitor at the time that the second, or any subsequent, Slate Declaration Form involving that Candidate is submitted to the Monitor.

Any Candidate who becomes associated with more than one Slate shall assume all the responsibilities for any and all Slates of which they are a member.

**Instructions**

The Multiple Slate Affiliation Declaration Form below must be filled out completely, and must be either typed or handwritten legibly in blue or black ink.

The Declaration must be signed by the Candidate. The Candidate declarant's signature may be handwritten or electronic.

As stated in the Rules, a Candidate associating with more than one Slate must obtain written consent from each of the members of each Slate with which they plan to affiliate. This written consent may take any form—including electronic or handwritten—so long as it can be verified as attributable to a member of a relevant Slate and reflects that the Slate member agrees the Candidate affiliating with multiple Slates may do so.

On the Declaration below, the Candidate affiliating with multiple Slates shall list the names of each of the members of each Slate with which they plan to affiliate, and the date of written consent from that Slate member. **Along with the Declaration, the Candidate MUST attach a copy of the written consent provided by each Slate member.**
