How to Use This Voter's Guide

Inside you'll find candidates' positions on a variety of issues. Answers are organized by contest beginning with candidates for governor followed by federal, statewide, state legislature, county, and city elections. Answers have been compiled in a non-biased, non-partisan format. Candidates were asked to complete a questionnaire by mail, email, and phone, or provide answers in cooperation with other organizations such as the Oregon Women's League.

While the majority of candidates responded to our questionnaire, some did not. For those candidates we have presented past voting records, endorsements, affiliations or other information that we hope will give you a better understanding of their position on these issues.

Candidate Notations "*" "**"

Answers in this guide are presented in a "YES" or "NO" format. On occasion, candidates include a comment which space doesn't allow us to print.

A single asterisk "*" next to a "YES" or "NO" answer is used to indicate the candidate included a comment.

A double asterisk "**" next to a "YES" or "NO" answer indicates the candidate declined to respond to the questionnaire, but their position was derived from other resources, including legislative records, endorsements, past questionnaire answers, or public records. Blanks are used when no meaningful information was found.

How the Questions Were Presented to the Candidates

Candidates were asked to provide a simple "support" or "oppose" answer, reflecting the kind of response they must ultimately provide as an elected official.

1. **Life.** Do you support or oppose a law in Oregon restricting abortion with exceptions only for rape, incest and the life of the mother?
2. **Abortion Funding.** Do you support or oppose the use of tax dollars for abortion?
3. **Tax Kicker.** Do you support or oppose the tax kicker law that returns over collected taxes to taxpayers?
4. **Healthcare.** Do you support or oppose state-funded healthcare for all?
5. **School Choice.** Do you support or oppose the use of school vouchers for K-12 grade education?
6. **Education.** Do you support or oppose lowering high school graduation standards?
7. **Police.** Do you support or oppose partially or fully defunding police departments?
8. **Liberty.** Do you support or oppose including religious exemptions in legislation to prevent restrictions of religious freedom in hiring and insurance mandates?

IN SOME INSTANCES, candidates declined to answer our Voter's Guide questionnaire. For those instances, we work diligently to provide as much information as we can through countless hours of research. We've included phone numbers when available and encourage you to contact candidates directly.
