

\$25000 VIP Shopping Spree Giveaway
Tuesday, November 1st, 2022 – Monday, December 5th, 2022

GENERAL:

The “\$25,000 VIP Shopping Spree Giveaway” contest (the “Contest”) is sponsored by Dufresne Spencer Group L.L.C. dba Ashley having retail locations in Arkansas, Illinois, Indiana, Kentucky, Louisiana, Michigan, Mississippi, Missouri, New Mexico, Ohio Tennessee, and Texas. No purchase is necessary. These are the official rules for the Contest (“Rules”). Valid at all participating DSG Ashley locations. The Contest starts at 10 a.m. CST on Tuesday, November 1st, 2022 (the “Start Date”) and ends at 9:00 p.m. PST on Monday, December 5th, 2022 (the “End Date”) (the period from the Start Date to the End Date referred to herein as the “Contest Period”). There are 34 days in the Contest Period.

ELIGIBILITY:

The Contest is open to all persons who have reached the age of majority at the time of entry (18 years of age or older). Employees of the Sponsor, its affiliated companies or agents, their respective advertising or promotional agencies, the third parties engaged by Sponsor to assist it in administering the Contest or a member of any such employee’s immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not) are prohibited from participating in the Contest. In these Official Rules, “immediate family” includes mother, father, brothers, sisters, sons, daughters, partner and/or spouse.

HOW TO ENTER:

Participants can enter to win in the “\$25,000 VIP Shopping Spree Giveaway” by submitting an online entry form or entering at participating Ashley locations. No purchase necessary to enter to win. All responders must provide a complete name, phone number, and valid email address to be eligible. All customers who sign up will agree to receive promotional emails and mailers.

CONTEST PRIZES:

The contest will have (4) Winners. Grand Prize winner will receive \$10,000 in Ashley credits, (1) winner will receive \$7,500 in Ashley credits, (1) winner will receive \$5,000 in Ashley Credits, and (1) winner will receive \$2,500 in Ashley Credits. The credits will be added to a customer account for in-store use at any DSG Ashley location only. The Prizes consist of the pre-tax amount of the purchase that was the basis for the selected entry. Winner is responsible for paying delivery fees, protection plans, and taxes.

DRAWS FOR PRIZES:

An email must be provided for an entry to be considered valid. No later than Monday, December 5th, 2022. The winners will be randomly selected. The selected contestants will be notified by email based on contact information provided by the contestant to Sponsor when submitting their entry. In the event that the selected contestant (i) cannot be contacted within (2) business days of being selected, another contestant will be selected, and the process outlined above will be repeated until a winner is declared.
