1. Update from Supervisor Horsley - Text

The district has approximately 150,000 people and I represent people from Menlo Park, San Carlos, etc but I'm speaking mostly about the Coastside (Pescadero to Devils Slide) in this update.

- There are a number of projects in Pescadero Including improving the marsh and working with the RCD. The inadequate fire station will be moved to the high school which will also involve moving a water line called CS7 from the fire station to the high school. This is a two-year project that will require a LCP amendment.
- Tunitas Creek Park will be the newest addition to the park system.
- There are homeless people in the creeks and Half Moon Bay and they will have an opportunity to be in the recently acquired hotel serving the homeless population. There are approximately 230 homeless people in the area at last count. There is some community concern that this hotel will have problems with drugs and such but it is not set up that way and it will have oversight. The coast may participate in this oversight. This hotel has 52 rooms and cost \$7.7 million. Is currently being operated by the Samaritan house but the county will release an RFP for over site. The goal is to serve the homeless that are living in the creek. Housing is for a set period of time to get people back on their feet. They will not be allowed to use drugs or alcohol while living there. This fits the state and counties goal of eliminating homelessness. The county also purchased a few hotels in Redwood City. And will will probably be looking for another one in Daly City or it South SF. Moss Beach Park is done.
- The Quarry Park pump track is coming to the board soon. We have a problem with people living in concrete boats and in Connex boxes. Upcoming project will be improving access at the half Moon Bay yacht club. Our parks department is undergoing fire reduction projects.
- Many areas of the county are under threat from Wildfire. There is a fire safety Council that works on fuel reduction projects. RCD has been assigned by the county to work on a programmatic plan for these fire reduction projects. On the coast you need a permit to take down these large trees so we're working on a plan to include all of these smaller projects under one permit. The RCD is a hidden jewel of the county. They do many projects to help land owners, like creek restoration projects as well and we want to secure more revenue for them.
- The controversial Cypress Point project will have 70 units for affordable housing and that LCP is going to the coastal commission. If it is approved the next stage is an EIR. And there

would have to be significant improvements to connectivity such as sidewalks and roadways. MCC has requested information about roundabouts since this is the preferred alternative.

- The Big Wave project development has county commitments for road improvements and bicycle improvements and pedestrian improvements. This development initially would have office space. that's now converted that idea and to high end storage units for high and vehicles. MWSD and GCSD will have a development commitment and this will have to go back to the board.
- The south parcel is boat storage. The county is considering purchasing the south portion for community center.
- Gray Whale Cove initially wanted to have asphalt but state parks didn't want that. County wanted to move the entrance for the south with a crosswalk. County planned to have an acceleration lane going south and flashing lights for a crosswalk. The county wants to do RRFB (rectangular rapid flashing beams) on the crosswalk but the state says that's not safe enough. The state also wants an ADA compliant sidewalk on the west side. I'm hesitant to ask the county to come up with a couple million dollars for these improvements especially for state facilities, not even county facilities.
- Medio Bridge eventually Alameda will become a street at some point but for now we want to continue placing riprap and replace the damaged bridge at the same location. The long term sheet piling he doesn't think will be approved because the wave energy bouncing off would need some sort of dampeners. Supervisor Horsley wants to replace the bridge in place because it's easier. It protects properties and it saves the county from a much more expensive solution. Going going to the coastal commission now. If the Coastal Commission kicks it back and says it has to go in a new location such as on Alameda, I want the MCC to do the outreach and supply the staff and financing to help MCC get it done.
- Just created a five group Resiliency District to deal with Sea level rise on the Coastside and Bayside. They may be a ballot measure to finance this district and it may be merged with the fire reduction.

Claire. I am wondering about the county budget. There are tech firms leaving, there's Covid expenses and there's the general business loss. How much of a hit do you think we're looking at?

Don. County manager says about 100 million Covid pandemic but Property values continue to go up and he's optimistic that we

will recover very fast. The biggest loss is sales tax from the airport and rental cars and went from 50 million people using it to 4 million. The county has significant reserve and will weather this well.

Dan. Interested in seeing the Medio bridge back in place and has elevated his interest in the erosion issue. He did a lot of research on different styles of armory and came across <u>SandSaver</u> made in Ohio in the shape of a K rail about 5 feet wide and 3 feet tall with holes to allow sand to be deposited behind the structure. Owners are so confident this will work they are willing to provide these units free of charge as an experiment in a partnership with the county. Do you believe Sandsaver is the premier method to protect from erosion? There are short term undesirables but if I could save the sand it would be worth it.

Don. Ask for Dan to send him information on Sandsaver.com and he will forward on to the engineers. The Army Corps of Engineers did a study on Sand moment Along from The Golden Gate bridge to the harbor.

The parallel trail has been going on for years, with generations of aids working on it from Nicholas Calderon to Elly Dallman and now Brae Hunter. When they dug out the footings they found a sewer pipe where it wasn't supposed to be and they needed to have seismic retrofit. We got all the funding with a \$400,000 grant from the city county associations of governments fund. now we need an encroachment permit from the school district but we cannot get this until we tell the school that they are in tired of the to compensation for us using property. We are contacting the school district to ask if they will allow us to do this work without the cost for an easement. Hopefully they will agree or If not we can cut off that link. Also need to do a soil study for lead mitigation plan and a tree mitigation plan. We hope to get it built this summer.

Gregg. 56 residents and I worked on a 7-page letter which we sent to the board of supervisors in 2013 to ask what is going on with disaster preparedness as a whole not just with wildfire with recommendations that you put someone in charge. In San Diego they have removed the eucalyptus trees which wasn't a short project but it wasn't eight years. Don't know where they got their funding but I shared those links. Why can't we get a task list? for example for 92 and Route 1 are evacuation routes flanked with eucalyptus trees which in fire would fall over and block the road. Why am I paying taxes to the county? I can't get fired insurance. Why can't we have a

task list and a regular updated report?

Don. We don't have a single person. We are relying on Nicholas Caldarone from the parks department and Jonathan Cox. They are working on evacuation plans and Nicholas is working on a report to the board. After the report is received by the board he would be happy to come to the MCC with Nicholas and talk about how they're going to get funding for this. It may be \$28 million.

Gregg. I have heard 60 million. Connect Coastside had 100 million or so. I'd rather get rid of eucalyptus.

Don. You can't just take the trees. You've got to do some restabilization of the soil. It's about 40 acres. We are thinking of doing a parcel tax to cover this. Maybe have a bimonthly email or Lena could share these updates with us.

Dan. Before we start giving estimates of costs we should talk outside the box to control the costs. Some of these trees could be used for fish ladders?

Don. We will have to come back to MCC with the fire guys to talk more about this. We used to be able to chip up eucalyptus trees and send them to China but we can't do that anymore. The cost of moving them is more than anything. Once you take the eucalyptus down you have to bury them I guess.

Don. In regards to evacuate and I know what I would do, I would make the road one way and move three cars down the road at a time. Zone haven has lots of information about vulnerability and how are you to shut down the road to traffic coming in and up and around to traffic going out. We should have a study session and talk about the zone haven system and how it works.

Michelle Dragoney. Why was the chipping service suspended? **Don**. I don't know. I'll get back to you.

Dave. It wasn't suspended they just didn't schedule additional days. **Michelle**. The Community was really into the wood chipping and we should get up and running again.

Dave. Medio Bridge -the armoring is quite extensive.

Don. I want to have Medio Bridge done before I leave office. Any alternative to the location would require eminent domain and a purchase of property plus a full EIR etc. - a 7 to 10 year project. We don't have to always agree.

Dave. As long as we can work together.

Don. The redistricting going on may give Don Horsley more Belmont. They are thinking of redistricting from east to west so that each board member would each have little pieces of the coast and Don doesn't think this would be good for Coastsiders. If the Midcoast incorporated with half Moon Bay since they have district elections we would probably be able to influence the city

Council quite a bit. There are 12,000 people in Half Moon Bay and 13,000 people in the unincorporated areas. There are three agencies with one sewer plant. All the special districts used to each of their individual plants and then were forced have a main treatment plan because they were all inadequate.

Gregg. They were not all in adequate. Montara had a two stage treatment plant and was forced to combine because the regulations changed and their outfall at the Fitzgerald Marine reserve was deemed illegal. Montara was forced to connect to Half Moon Bay but does not want to pay for the infrastructure. The reason we don't get along with Half Moon Bay is because of mismanagement and costly mistakes.

Don. But you have 13,000 and they have 12,000 so you would have a say.
