RESOLUTION AND ORDER ABANDONING A PORTION OF PACIFIC AVENUE EXTENSION, SAN MATEO COUNTY

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

whereas, pursuant to Resolution No. 38072 adopted on December 13, 1977 , declaring its intention to abandon a portion of Pacific Avenue Extension in the County of San Mateo, this Board caused notice to be given of a hearing to be held thereon; and

WHEREAS, affidavits of publication and posting of said notice pursuant to said Resolution have been received and filed; and

WHEREAS, at the time and place of said hearing, this Board heard all evidence offered by all parties interested in said abandonment:

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED and ORDERED as follows:

- 1. That the Board of Supervisors finds that the hereindescribed portion of Pacific Avenue Extension in San Mateo
 County, more particularly described in Exhibit "A" attached hereto
 and made a part hereof, is unnecessary for present or prospective
 public use, and it shall be and is hereby abandoned.
- 2. That the Clerk of this Board shall cause a Certified copy of this Resolution to be recorded in the Office of the County Recorder.

EXHIBIT "A"

All that portion of Pacific Avenue Extension lying westerly of the Coast Highway and running from the south-westerly line of 4th Street to the northeasterly line of 7th Street.

EXCEPTING THEREFROM those portions of Pacific Avenue Extension which coincide with 5th Street and 6th Street (now known as Seacliff Court);

AND RESERVING THEREFROM an easement for public utilities across the entire length of the westerly 10 feet of Pacific Avenue Extension above described;

AS SAID STREETS, Highway and Extension are shown on that map entitled "MAP OF A RESUBDIVISION OF ALL OF FARALLONE CITY, SAN MATEO COUNTY, CALIFORNIA", which map was filed in the office of the Recorder of the County of San Mateo, State of California in Volume 6 of Maps, Page 2 and disclosed by Record of Survey filed in Volume 6 of L.L.S. Maps, Page 148.
