Minutes for Meeting of September 23rd, 2020

Call to Order (7:05pm)

All Council Members present. Total attendance 44, including 22 members of the public. Meeting held remotely via Zoom due to COVID-related restrictions.

- 1.Board of Supervisors Report and Reports from other Governmental Bodies Lena Silberman of Supervisor Don Horsley's Office--
- --Census continues, with low participation in Pescadero
- -- The County has advanced to the "red" tier of COVID restrictions, allowing more openings. Testing is being increased
- —CZU fire is 100% contained. County is working with the Resource Conservation District to reduce future risks.
 - —Annual allotment of funds for MCC operation has been approved and will be issued
- —There will be a Board of Supervisors study session on vegetation management on 10/14 at 9 am
 - —Comment period for Caltrans Traffic Improvement Project is extended to 10/11
 - —Len—There will be a public meeting on Caltrans impacts on SR1 on 10/6 or 8
 - —Dan—A 9am meeting is inconvenient for many
- —Gregg Dieguez—Asked for a report on County funds allocations.—This was clarified that the report was only on the authorization of MCC funding. Harvey Rarback reported for the City of Half Moon Bay
- —The Public Safety subcommittee referred the case of the shooting of resident Sandra Herman to the Attorney General for review.
 - —City Council to consider Land Use Plan for LCP update at 6pm 9/30
 - —Caltrans will present Traffic Improvement Plan to City Council 10/6

Barbara Dye of Grenada Community Service District reported that a review of plans for the park at the Burnham Strip would be held 9/24

Ed Larenas--concerned about 1pm Harbor District meetings being inaccessible for many

Liang--BoS should require Special District meetings be held in evening

Dave--videos of candidate forums are available.

3. Consent tabled due to inaccurate dating

4.a Building Defensible Space and Vegetation Management for Fire Risk Mitigation

Barbra--There are usually 3 fire engines and 1 ambulance available and there has been no update on evacuation planning, which was funded by \$75,000 in 3/19, which

should be a priority before large developments or CTC approval. Encourage joining CERT.

Dan--personal history of fire concerns colors his current worries about it.

Presentation by Kate LeGros, urban forester.

Barbra--how to prevent erosion after cutting trees?--leave root in ground. New planting.

Dan--Use of compost?--Growth of new planting encouraged by tilling before planting, use of bio-char and micronutrients, and irrigation for a few years.

Kimberly Williams--How to reduce risk of using plastic to discourage regrow from stumps?--Follow up in a year and remove if possible. Tarp is too permeable. Chemical treatment is the last alternative to stump grinding and plastic covers.

Michael P--County land is within 100 feet of his house. In the CZU fire, road closures complicated evacuation.

Dan--early regrowth can be broken off. Could sheet metal be used instead of plastic?---Probably not

Len--Kellyx of RCD will be at next MCC meeting

Gregg-- factors other than vegetation contribute to fire risk. Multiple agencies involved Claire--appreciates practical scientific approach

Michelle Dragony--is there a market for eucalyptus products?

Dave--No commercial market for this species of eucalyptus

Dolores Silva--Fire risks, including grove north of the tunnel, have implications for development.

Dan--Multiple agencies are involved

Presentation of CTC Outreach Summary by Katie Faulkner and Chandra Singh Projected approval of CTC by BoS 4/21

Joe LaClair--summary comments

Dan--Why didn't you include public comments? Why not include underpasses?

Claire--Did Joe say that completing CTC will allow changes in lot development cap?
--No. That remains in t LCP

Dave--Are there time limits on lot retirement or merger?--Currently lot mergers will be voluntary with incentives for one year, after which they will be mandatory.

Barbra--Why consider the overpass in Montara if the 16th St bus stop is eliminated?--Existing Bus stop at 14th northbound is not eliminated, just the proposed new stop at 16th, Reference to potential overpass relates to abandoned WWII structure.

Dolores--Concerns about development cap application/exceptions in Cypress Point development.

Gregg--Complicating issues of COVID, sea level rise, evacuation routes, visitor traffic should be considered before CTC

Dan--Why is this so confusing? Why does Caltrans keep having new ideas? Why do they propose a crosswalk in Miramar when there is already a culvert people can walk through?--There is an active effort to improve coordination between Caltrans, the County and others

Barbra--CTC should coordinate with OES, CalFire and others. Local Hazard Mitigation Plan should be updated.---The office of Sustainability is tasked with including fire, disease and other risks in an overall approach

Dolores--Is buildout compatible with evacuation?--integration of planning aspects in key

Marcia Yeates--Evacuation planning is important

Dan--there are wildlife underpasses near Truckee

Len has an extensive list of comments made by the public and a list of 5-year priorities but wants to talk about them at a later time.

d. Midcoast Newsletter

Presentation of draft first-issue newsletter by Michelle

Dave--update CZU fire article, update information on Medio Bridge bypass, eliminate list of MCC priorities, which have not been approved by MCC

Claire and Barbra--cite comments by Lisa Ketcham including explaining pump track and correcting dates. Support removing priority list and renaming to indicating more of a community focus

Dan--A balance of potentially conflicting interests is important and this takes a lot of effort.

Dan/Len--discussion of perceived problems with process

Dan/Michelle--discussion of the degree to which Dan has been able to participate in newsletter planning

Claire/Michelle--Font may be made easier to read, but font choices are limited Barbra--wants more uniquely local stories. Newsletter focus can be modified in the future.

Motion to approve publication of newsletter with edits cited made by Dave and seconded by Barbra. Approved 5-1, Dan voting no.
