<u>Dog Access Pilot Project Work Group Recommendation:</u> <u>Off-Leash Dog Access Program</u>

Process

Throughout the 11-meeting work group process, the Dog Access Work Group ("Work Group") agreed to use the consensus decision-making method of "Fist-to-Five" (three fingers means the member can live with the decision and will not undermine it; less than three fingers means the member does not agree, and three to five fingers indicates the level of agreement). In the case that consensus was not possible, the work group used a majority vote.

Recommendation

A. Policy Guidelines for Off-Leash Dog Access Pilot Program

At the December 3, 2019 meeting, there was consensus among Work Group

members to recommend the following policy guidelines for the off-leash dog access
pilot program:

- (1) Off-leash dogs must be under voice and sight control:
 - a. Voice and sight control means the owner/handler must be in control of dog at all times and must be able to recall and leash dog at any time.
 - b. Owner/handler must have a leash for each dog under owner/handler control.
 - c. Dog must return immediately when called (within 10-second return time).
- (2) Dogs must remain on designated trails, within view and earshot, and no more than 25 feet away from owner/handler.
- (3) Dogs must be on-leash in developed areas (i.e. near traffic, parking lot, lawn or play field deck, picnic areas, etc.).
- (4) No more than two dogs off-leash per owner/handler.
- (5) Dogs are presumed to NOT be under control when they:
 - a. Threaten, harass or chase other animals or wildlife;
 - b. Display threatening behavior;
 - c. Physically harm people directly or indirectly by their actions;
 - d. Touch or jump on other park users who have not invited or engaged in interaction with the dog; or
 - e. Do not return when called (as previously defined).

NOTE: This highlighted section will be discussed further at the January 13, 2020 work group meeting.

The Work Group could not reach consensus regarding the sixth policy guideline (listed below), so the Work Group voted. Eight members supported the sixth policy

and two were opposed (one member was absent). Reasons for opposition to the policy below included concerns that this policy would make it illegal for two separate visitors with off-leash dogs to let them encounter each other off-leash.

(6) Dogs must be recalled and leashed when encountering others.


B. Two Off-Leash Dog Access Pilot Locations: Quarry Park and Pillar Point Bluff

(1) Quarry Park: Off-Leash Dog Access Pilot Location #1

At the October 7, 2019 meeting, the Work Group confirmed its consensus decision to recommend piloting off-leash dog access at Quarry Park.

Proposal at Quarry Park (see map below)

- On-leash dogs are allowed on all trails
- Off-leash dogs are allowed on designated multi-use trails
- To protect children and sensitive species and habitat, dogs are not allowed in the playground or pond.




(2) Pillar Point Bluff: Off-Leash Pilot Location #2

Becuase the Work Group could not reach consensus after discussing off-leash dog access at Pillar Point Bluff over three meetings, the decision was reached through a majority vote at the November 7, 2019 meeting. Seven members voted in favor of the proposal below, two members were opposed, and two members were absent. Reasons for opposition to the proposal below included concern regarding proximity of off-leash dog access areas to the marine reserve and seal pup habitat, and the need for a full environmental study to identify any native or protected plants and wildlife at Pillar Point Bluff.

Proposal at Pillar Point Bluff

- Sections of trails in Pillar Point Bluff are open to dogs off leash and under voice and sight control of their handler(s). See map:
 - Jean Lauer Trail, post 3-15
 - o Ross' Cove Trail, post 5-17
 - o Between post 3 and 5
- To protect sensitive species and habitat, dogs are prohibited in all marsh areas, on all trails leading down to the beach, and on the entire beach.



C. Criteria for Evaluation of the Off-Leash Dog Access Pilot Program

There was consensus among the work group members to approve the following evaluation criteria for the off-leash dog access pilot program.
