Cathrine:Slater Carter:: MCC has been against these variances for a long time. Our letter should be much stronger. The design review standards should be observed and not allow this house being built as designed. We don't want to look like Daly City. June 7 hearing an appeal on Miramar for wetlands and sidelands and sensitive habitats.

Ms. Vespriimi: If you don't have a big enough lot, you need to buy more land. Not fair to the community.

Leonard: Zoning overlay. Seal Cove is geologicly dangerous and that's the reason for the large size lots. No deviation from the zoning overlay because of this
