PLN2005-00158: Emergency CDP to perform maintenance dredging this year only around the water supply intake pipes at Denniston Reservoir on Denniston Creek in Moss Beach. APN: 037-320-150, 037-320-280.

Applicant: Coastside County Water District **Owner:** Same **Planner:** Matt Seubert STATUS: The proposed project is 400 cubic yards of dredging of Denniston Reservoir near an existing CCWD water intake valve. The reservoir is located approximately 0.5 miles northeast of Highway 1, accessible via an existing farm road opposite HMB airport. These dredging activities will remove silt and vegetation over an approximately 40 linear foot area. The water district has an existing permit for this work that was originally issued in 1998 (County File No. CDP96-0039). The CCWD applied to renew that permit on April 25, 2005 for dredging annually for the next five years. (The MCC reviewed that application on 5/11/05.) County review of that renewal application, however will not be heard before the County Planning Commission until 2006. To accommodate this year's needs, the CCWD requested an emergency CDP. This emergency permit will allow the CCWD to dredge the reservoir this year only. Additionally, the dredging activities will be subject to all conditions of approval outlined in the previously issued permit. Dredging activities in subsequent years or any additional maintenance activities proposed by CCWD will have to be approved by the County Planning Division. Comments due prior to September 12, 2005.
