- Solicitation of Public Comments regarding the extension of the Urgency Interim Zoning Ordinance for the Midcoast enacted by the San Mateo County Board of Supervisors on December 7, 1999. The Board will consider extending this urgency ordinance for 10½ months at their meeting on January 11, 2000. The urgency ordinance establishes a building height limit of 28 feet above natural grade (or lowest floor) throughout the Midcoast, and implements daylight plane and floor area ratio controls in the R-1 (Single Family Residential) zoning districts, pending completion of a thorough review of County zoning regulations.
