## Regular Agenda

The Council may vote to take appropriate action on any of the following items:

1. Presentation and public comment regarding the Urgency Interim Zoning Ordinance for the Midcoast and proposed permanent zoning regulations. Representatives from the County Planning Department will review the components of the ordinance (floor area ratio, building height and method of calculation, daylight plane) for residential construction projects. Possible formation of an Architectural Review Committee for the Midcoast will also be discussed. Following questions to County staff from the audience and Council members, the public will be invited to comment on the proposed regulations.

The Council will deliberate and formulate a recommendation to the Board of Supervisors regarding the specific regulations to be contained in the final ordinance and any attendant changes in County staffing or policy necessary for the successful implementation of the new ordinance. Note: Once the final ordinance has been proposed by County staff, it will be heard before the San Mateo County Planning Commission, the Board of Supervisors, and the California Coastal Commission. The public will have the opportunity to comment at each of these hearings. **Sponsor: April Vargas. Estimated Start: 8:00 p.m.** 

**2.** Update on continuing Council projects. Brief status reviews, and possible direction, on in-progress projects.
