- 1. Discussion and recommendation to the Board of Supervisors regarding the Moss Beach Highlands project.** (Postponed from May 10.) The San Mateo County Planning Commission recommended approval of this project, comprising 73 affordable senior rental apartments and 55 non-affordable single-family dwellings, on April 26 by a 3 to 2 vote. The project is currently re-scheduled for the Board of Supervisors hearing on June 6. **Sponsor: Paul Perkovic. Estimated Start: 8:00 p.m.**

- 2. Discussion of Midcoast Community Council participation in a joint committee with the City of Half Moon Bay and other interested parties to explore options for Midcoast self-government. Sponsor: Ric Lohman. Estimated Start: 9:30 p.m.**

- 3. Revisit draft Residential Zoning Ordinance revisions following the San Mateo County Planning Commission hearing.** The Council may revise recommendations based on new information. **Sponsor: April Vargas. Estimated Start: 10:00 p.m.**

- 4. Update on continuing Council projects.** Brief status reviews, and possible direction, on in-progress projects.
