NEW BUSINESS

1. ABAG PROPOSAL **Estimated time: 7:30 pm**

The Association of Bay Area Governments (ABAG) has issued a Request For Proposal in which they offer to fund "subregional planning groups." The City of Half Moon Bay is proposing to submit a proposal, in which Pacifica, Half Moon Bay, the MCCC, and the County would participate in such a planning group. Representatives from Pacifica will present their ideas. The MCCC may decide to participate.

2. FOGG (Forms of Good Government) REPORT **Estimated time: 8:15 pm**

A group of community residents, along with three members of the MCCC, have been meeting for about six months to discuss options for local control. The Council and community will receive a status report, and there will be a question and answer period.

3. REVIEW: 2009 VALLEMAR, MOSS BEACH **Estimated time: 9:30 pm**

In December 1995, the MCCC voted to recommend against certain zoning requests made by the owners of 2009 Vallemar. These owners have asked the MCCC to hear additional information, and consider changing its position.
