Re: Previously Petitioned for Road Improvement Projects - Midcoast Area

The Board of Supervisors recently approved plans and specifications for the 12th, 13th and Farallone project, we opened bids on August 6th, and we expect to be before the Board on August 20th, awarding a contract for this work.

The Board also directed staff to report back to them on the status of other "petitioned" projects in the Midcoast that were previously submitted. The majority of these petitions were submitted prior to 1990 and before the County surfaced all the rock roads, and prior to the adoption of new standards for the area.

Attached is a list of the outstanding petitions and their status. Construction of some of these projects were initially delayed as the special districts (sewer and water) serving the Midcoast, complained that these projects could financially impact these districts due to the cost of relocating district facilities in conjunction with the proposed road construction.

The Board of Supervisors agreed to coordinate the road work with the special districts, and in some special instances to defer construction if it caused too much of an impact to the district. An example of this is the Avenue Balboa project which was designed and plans prepared based on the previous standards, but never built due to the impact on both the Granada Sanitary and Coastside County Water Districts.

We are now proposing the following steps to respond to the Board's direction and to determine if there is still interest in the previously petitioned projects:

- Contact the respective districts to determine preliminary impacts to the districts if these
  projects went forward using the new road standards.
- Poll the property owners in each petitioned area sequentially, after we receive feed back from the special districts as to the impacts on their facilities and their ability to finance any work on their facilities that may be required as a result of the road improvements, to determine if there is still 60 percent (60%) support for each project using the new standards. We would provide the property owners their estimated assessments based on the fixed assessment method recently approved by the Board.
- Report our findings to your Council.
- Report our findings to the Board of Supervisors together with your Council's recommendations. The Board could then provide direction of project priority and funding.

I would appreciate your input on the above process, as I am proposing to determine current owner interest in these projects prior to our proceeding with developing other priorities for projects in the Midcoast.
