Re: Resolution of Application to LAFCO for formation of a Coastside Park and Recreation District

#### Honorable Board Members:

At its meeting of January 10, 1994, the MidCoast Community Council voted unanimously to request that the Board of Supervisors adopt a resolution of application to LAFCO for formation of a Coastside Park and Recreation District. After extensive investigation and discussions with County staff, the Council believes that a new Park and Recreation District for the unincorporated Coastside is the most appropriate public entity to improve and operate the future park at the former El Granada Quarry, purchased by the County in November, 1993 for such purpose. Under provisions of the purchase, we understand that a new public entity must be established and provide park services by November, 1995. We therefore request that this resolution be adopted by the Board as soon as possible, so that the LAFCO proceedings may be completed to allow for a public vote in November, 1994.

The Council favors the formation of a Park and Recreation District for the following reasons:

- The County has previously expressed its intentions of assisting the Coastside communities in acquiring parkland, but does not desire the responsibilities or costs of park improvements, maintenance or operations.
- There are no existing public agencies within the unincorporated Coastside which have
  the focus or expertise in areas of public recreation services. Previous considerations
  of joint efforts with the City of Half Moon Bay, which has a park and recreation
  program, have been unsuccessful due to concerns about the electorate's access to and
  control of an extragovenmental agency.
- A Park and Recreation District would have a locally elected board, be able to raise funds through various means, and would be directly accountable to Coastside residents.
- A local Park and Recreation District would be best able to develop a comprehensive recreation program for the Coast, reacting to opportunities to acquire additional

properties, responding to residents' complaints and requests and preparing a long range master plan.

We greatly appreciate the support provided by the Board and by Deputy County Counsel Michael Murphy and Matt Greenberg.

#### BALLOT ARGUMENT IN FAVOR OF MEASURE E: MIDCOAST COMMUNITY SERVICES DISTRICT



# Nine declare for Mid-Coast park board

Nine residents have declared their candidacies for five open posts on the proposed Mid-Coast Community Services District, which would govern parks and recreational services on the Mid-Coast.

Voters in the unincorporated areas will choose the five-member board to operate the district, which would fund and operate the proposed El Granada Quarry Park.

The county purchased the quarry land for a park from Half Moon Bay businessman Keet Nerhan in 1993. Mid-Coast officials have until November 1995 to find funds to reimburse the county and begin park operations.

Two Mid-Coast Community Council members, Bob Brown and David Spiselman, have filed for seats on the board.

Moss Beach residents Bill Kehoe and Barry Dorland, El Granada resident Fran Pollard and Montara residents Lane Williams Lees, Andrea Brown, Beverly Garrity and Bob Ptacek have also filed.

There are a number of related ballot measures that must be approved for the board to become a reality, however. In addition to choosing the five-member board, voters must approve the actual creation of the district and approve a \$12 per year parcel tax to fund it.

El Granada voters also will be asked to cast an advisory vote for an additional \$46 assessment to purchase and improve the quarry property.

"Districts have got to look to manage their own assets the best they can," said district Superintendent Jane Martin, pointing to the financial hit schools have taken since the passage of Proposition 13.

Yet some of the developments proposed by Krupp — such as the construction of up to 113 new homes in El Granada — will surely not sit well with local residents opposed to further development on the Coastside.

Trustee Mary Freeman-Dove said it was "bad timing" by the board to begin discussing the development of the properties before the November election, when three seats on the board will be up for grabs.

"There is such emotional attention focused on growth," she said. "The board needs to be sensitive because the community is just as much an asset to the district as anything else."

Although Krupp has yet to provide formal recommendations, he suggested in a presentation at the end of July that the district could make up to \$10 million on the development of the two vacant properties alone.

The district has also started tentative discussions with the City of Half Moon Bay to create a redevelopment project including the two downtown sites. Rebuilding Hatch School on another site could generate significant profit for the district, Krupp said

"This is one giant step ahead," said Trustee Toni Foster. "If we wait for down-the-road to come to us, we'll never get there."

"I don't see it in the context of pro-growth," she

Anticipating what could be strong opposition from neighbors of the currently vacant sites, Redmond said residents always have an option: They could block development by buying the land themselves.

"There is far too much land grabbing going on in this country and in this area in particular," he said.

Krupp said he hopes to issue a final asset manage-
