**Motion:** (Fitting/Marsh) LAFCO application to be amended to request that a **Community Services District be established in the MidCoast for the purpose of providing parks and recreation services only, with the dissolution of County Service Area 12. MCC to recommend that LAFCO allow for the election a CSD board, separate from MCC. If LAFCO mandates that MCC and CSD boards be one and the same, appropriate adjustments will be made. Motion passed 6-0**
