Meeting Minutes September 9, 1992

- 1 Call to Order at 7:10 pm Present: Bledsoe, Campbell, Dove, Marsh,

- 5 Public Comment  
Mr. Walsh presented a handout which expressed his concerns regarding the impending sewage treatment plant expansion and the inconsistencies in the answers (flow vs. cost information) he received from SAM & its consultants. Ms. Hanson asked that Meeting Agendas be made available. Ms. Chapman of Supervisor Eshoo's office explained that she could provide the Council a student intern to help us serve the community. Mr. Iverson of the Half Moon Bay City Council invited the Council to the Monterey Bay Marine Sanctuary activities: September 14th celebration at the Harbor and September 29th workshop. Ms. Campbell announced a program sponsored by Saint Catherine's Hospital and Dr. Enriques to donate their medical services to the community.

Treasurer Ms. Campbell provided a reconciliation \$393.75  
Newsletter Ms. Campbell discussed the upcoming Newsletter. Ms. Chapman of Supervisor Eshoo's office will help with a mailing and production costs. **The Council voted (M/S/P 4 - 0 ) to set a ceiling on "seed" expenditures of \$150.** The newsletter will function as a fund raiser and community information service.  
Facilities Mr. Dove announced the opening of the new MidCoast Community Council office, which has been relocated to the Main Airport Terminal Building. Thank you Mr. Sands of DPW and Mr. Peterson and Mr. Manning of the Airport. Ms. Campbell said that tomorrow night the Montara Paving (5th - 8th Streets) group will meet in the Office to discuss the current status  
Water Mr. Ptacek reported on recent Montara Sewer Board meetings.  
Land Use Mr. Dove announced that the County Golf Task Force (Supervisor Huening) was considering the fields across from the Airport, and the Edgewood site; Marsh Road site is no longer being considered.  
Park & Rec. Dr. Quest discussed the regional Coastside Park & Rec. proposal; what with the current fiscal state, few politicians from School Board, City of HMB, and County appear likely to push for more "taxes" to support such an undertaking. A bedroom tax on new housing might be the most palatable financing method, although a parcel tax might be as little as \$100.

Highway The Council meeting on September 23 rd will address the Highway One issues with Cal Trans, Mr. Cullen of DPW; a stoplight at California, Moss Beach, and radar guns to control vehicular speeds.

Education Mr. Dove announced that Ms. Marks of Mr. Huening's office has established a No Dumping stencil for MidCoast use on October 3, and asked for volunteers.

All participants have confirmed and there will be no advance notice of the questions. Ms. Bledsoe will moderate.

9 Heritage Site, proposed development

Ms. Roberts of the Committee for Green Foothills made a presentation of the current status of the project: there are no limits, few controls, and no factual descriptions of the proposal. As such the intent of Measure A is being circumvented. Representatives of the developers declined to participate. The Council voted ( m/s/p 4-0) to oppose the development, to so advise the County, and to ask the County take a similar stand.
