- 7. Half Moon Bay/Coastside Assessment District

David Criste, County Director of Parks and Recreation, and Therese Ambrosi-Smith, Half Moon Bay Director of Parks and Recreation, made a presentation regarding the Lighting and Landscape Act of 1972 and its potential in developing a community park on the Coastside.

Their concerns included the following:

- Lack of representation of the unincorporated area in the administration of the District or the park;
- Assessments can change annually;
- Advisory votes are non-binding;
- Annual assessments for maintenance would be made;
- No new taxation was appropriate;
- Parks and recreation facilities are not needed;
- The park site might be located in the City of Half Moon Bay.

Motion (Ayers/Campbell): That the Council send a letter to the Board of Supervisors indicating that the November 4 letter did not adequately represent the of the Council and the community, and that options other than a Landscape and Lighting District would be examined to fund parks and recreation on the coastside.

Motion failed on a 3-3 vote (Meyer, Brown, Marsh opposed)

Motion (Ayers/Campbell): That the Council send a letter to the Board of Supervisors indicating that the November 4 letter was premature, did not accurately represent the sentiment of the community, and that the Council is opposed to a Landscape and Lighting District in conjunction with the City of Half Moon Bay.

Motion passed on a 4-2 vote (Marsh, Brown opposed, wishing to not close any options without further study and community input).
