CHARTER OF THE PRINCETON, EL GRANADA, MOSS BEACH, MONTARA COMMUNITY COUNCIL

This Community Council shall be created to serve the following purposes:

- 1. To provide the Community with a more effective means to express its views to the County of San Mateo and other governmental agencies on matters of concern to the Community;
- 2. To contribute to the Community's awareness of issues of public import by providing a forum for discussions, and sponsoring meetings, discussions, and other events which will contribute to the general welfare, knowledge and awareness of the Community regarding such issues;
- 3. To provide a vehicle for exploring the feasibility and merits of incorporation of the urban and rural lands in the Community into a town or city;
- 4. To assist the Community in developing and expressing a long-range vision of the Community which meets the desires of its residents for an improved quality of life, protection of the environment, and sound economic planning for growth;
- To assist the many associations, organizations and ad hoc groups of Community citizens who seek to communicate with the County of San Mateo and other governmental agencies about matters of great public interest in bringing their issues before the Community and in representing the Community before such governmental bodies; and
- 6. To seek to preserve the rural, small-town character of the Community by protecting the existence of agricultural lands, supporting the retention of a Greenbelt around urban areas of the County, maintaining the coastal protections afforded by the County Local Coastal Plan and Measure A, and seeking to control growth in a manner which is consistent with the present character of the Community.

The next meeting of the newly formed Coastside Community Council is scheduled for Wednesday, January 17. Take this opportunity to join a growing number of your neighbors and friends who are determined to have a voice in determining the future of the Coastside. Join us at 7:30 P.M. at El Granada Elementary School for an evening of important dialogue and information.

Coastside Community Council Meets on December 13th — Standing-Room-Only Crowd Adopts Charter

standing-room-only crowd of nearly two hundred fifty attended the second community meeting of the unincorporated Coastside towns on December 12 at the Farallone Vista School. The first meeting, held November 15 at Montara Gardens, had about fifty Coastsiders attending. The main goal of the second meeting was to adopt a charter defining the purposes of a Coastside Community Council. Goal accomplished. The primary function of this council will be to give the unincorporated communities of Princeton, El Granada, Moss Beach, and Montara a greater voice in determining the future of developments in the midcoast area.

The meeting was conducted in an informal town meeting manner, with El Granada resident Michael Day acting as moderator. The agenda included adopting a Charter, discussing how the future Council might be organized, expanding committees already formed, creating new committees as needed, and discussing suggestions about the formation of the Community Council.

Following the November meeting two alternative Charters were drafted which outlined the purposes and goals of the Community Council. Alternatives A and B of "The Charter for Princeton-El Granada-Moss Beach-Montara Community Council" both had five stated purposes which were nearly the same. Alternative A, however, had a sixth point that specifically stated preservation of the rural flavor of our community as a goal of the Council (see Charter, page 1). Many people offered views regarding the pros and cons of each alternative of the Charter before an informal vote was taken. The majority of the residents who spoke were in favor of alternative A with its stated goal of preserving the rural character of the coast. When the vote was taken, Iternative A was selected by an overwhelming margin.

Next on the agenda was a discussion of the organizational structure for a Community Council representing the unincorporated areas. While no decision was made on this point, several ideas were suggested for the Council, including traditional town meeting, informal body of residents elected to their positions, and a non-profit corporation with a formal governing body. Daniel Moses, a Princeton resident, spoke eloquently about the advantages of a general meeting providing an opportunity for all interested people to voice their opinions and vote on important issues.

Another issue discussed was the possibility of incorporation of our towns, versus annexation to the city of Half Moon Bay. The meeting moved on to introduce individuals who had previously volunteered to the various committees. Five committees have been formed to accomplish a variety of tasks — Steering Committee, Organizational Committee, Research/Legislative Committee, Publicity/Newsletter Committee, and Fundraising Committee. The Steering Committee, headed by Nancy Maule of Montara, is serving as the interim Council until the Community Council is formed. The chair of each committee will meet with the Steering Committee to coordinate their efforts before the next Coastside Community Council meeting on January 17 at El Granada School.

Supervisors Agree to Hold Important Meetings at Coastside Locations

or coastal residents it has been a problem to attend hearings on issues affecting their community, because most of the hearings are held during the day in Redwood City. We have also heard that the board intends to hold future meetings in the midcoastside when other important issues arise- such as the Princeton rezoning. The time and place of this meeting will be announced by mid-February and it is possible that the meeting will be held at Farallone View School. Look for this news- it is a most important meeting for our future as a liveable community.

Meanwhile, residents should not forget to take advantage of the opportunity to call or visit the office that Anna Eshoo, another county supervisor has opened in Princeton. It is staffed by her aides and will be open each Monday morning from 9 to 12. The telephone number is 728-7993. It seems that coastsiders are beginning to get response from two supervisors: may the trend continue to include the other three!

OCAL SSUES

Following is a list of a few major issues facing each and every coastside resident. All efforts have been made to provide accurate and current information. Individual contacts listed below can provide more details on their respective issues. We encourage your feedback and views on these and other coastside concerns for our next newsletter.

Proposed Pillar Point Harbor Village

A 94-suite hotel, enclosed mall with 25 shops and a 340-seat restaurant and bar located at Capistrano Avenue and Hwy 1, was approved by the San Mateo County Board of Supervisors despite overwhelming opposition by coastside residents. Local

concerns are that the project will block views of the harbor and Half Moon Bay coastline and will subvert the small town rural character of the coastside. STATUS Appealing to the Coastal Commission, filing a CEQA (California Environmental Qualtiy Act) lawsuit against the County and Westinghouse — stating the EIR (Environmental Impact Report) is deficient. "It is important to size down and resite the development because this will set the tone and scale for future development on the coast." DESPERATELY IN NEED OF \$\$\$ TO PURSUE LAWSUIT. Montara State Beach Parking Lot

A parking lot accommodating 158 cars and 3 buses has been proposed 1000 feet north of the Chart House Restaurant on the coast side. Fifteen picnic tables, locking bicycle parking and bluff top trails are planned. The Coastal Commission delegated the authority for granting coastal development permits to San Mateo County. A public hearing at the San Mateo County Planning Commission for this coastal development permit will be held January 18 in Redwood City.



This park with over 600 acres of open space is located on Montara Mountain between Gray Whale Cove and Montara with access adjacent to Martini Creek

(on Hwy 1 south of Devil's Slide). Long time residents have used Farallone cutoff and San Pedro Mountain Road to gain access to the state park however new owners of the property threatened continued usage. McNee Access Group was formed by local residents to secure continued usage of these two important trails into the state park.
