Minutes: Minutes of the March 15 Steering Committee meeting were read and approved by consensus.

Reports:

Organization - C. Koepf reported committee is 2/3 done with by-laws, will finish in 1 or 2 meetings, need to schedule workshop, will look at precinct map & representation next. N. Hansen said Richard Silver suggested 9 members because less infighting & easier to get a consensus. He said just put together simple by-laws & Anna will present the resolution. Nancy has been in touch with Phil Taylor of the Gualala Area Coalition who will attend the next town hall meeting & she presented the org. committee with Coalition documents for their review.

Publicity - C. Ware reported they have completed the flier for the town hall meeting & will distribute it in Montara & Moss Beach. N. Hansen & J. Celestre will distribute in El Granada & B. Mahar will do HMB. There will be a press release in the Review. They have their assignments for next newsletter which will be ready for our Earth Day table.

Research - N. Hansen reported S. McElroy offered to help the org. committee with the Bd. of Sups. proposal.

Issue Awareness - ? reported a rumor that someone wants to rename Pillar Point Harbor - Half Moon Bay Harbor.

Fundraising - N. Hansen will speak to J. Macias about subscriptions to our newsletter such as the Gualala example. Motion was made & passed that fundraising co. include membership solicitation. J. Celestre commented that we need support from the business community.

Treasury - N. Hansen submitted the Treasurer's Report (attached hereto) for M. Dolmatz. The McElroys donated the cost of Sokolow's dinner. We authorized by consensus money for the fliers. D. Sadlier's motion to print newsletter with the \$240 needed to be raised at town hall meeting, by individual contributions &/or

fundraising events was carried. C. Ware will investigate Iverson's group as a possible nonprofit umbrella for ours.

Special Topic Discussion:
