Old Business:

1. Topics for Jan. Town Meeting

A. Confirmed that Bill Mahar will be master of ceremonies. Anna Eshoo sent two letters - she has distributed our materials to the Board & to County Counsel Casey; Casey is working on a Memo addressing issues in the Bylaws.

B. Nancy will report on her summary of candidate qualifications at our next meeting.

C. Jerry Laster & Bill Mahar will field questions re Bylaws before the public vote & give a short history of public invitations to work on the bylaws. Bill will confirm this with Jerry.

D. Campaign Conduct - Cynthia brought materials she received from the Fair Political Practices Co. (FPPC) & County Registrar of Voters. Lempert's office said it's unlawful to impose contribution or spending limits. Discussion - we can encourage limits and public contact in the spirit of our organization. We will try to get new people at Town Hall Meeting to get involved with this, if not, steering co will do it. Cynthia will ask Karen Keane to head this co. because of her election experience.

2. Bill Mahar reported EG School charges \$30 for the room & \$60 for custodial fees but Mr. Owens will charge us the \$30 fee only.

3. Nancy reported flyers are ready & press releases were sent to Beachcomber, Review & Times on Jan. 2.

4. Flier distribution was confirmed. In addition, Denis & Judy will do Mobile Home Park and Judy & Nancy will do Moss Beach Post Office.

5. Pamela was called. She will find out how the League of Women Voter's can help us & if they will be present at TH Meeting.

6. What Else?

Bill will have a tentative TH Meeting agenda by next week's meeting.

Nancy will invite Supervisors to TH Meeting.

Bill reported on Intergov. Meeting where the new joint powers agreement was discussed.
