# MIDCOAST COMMUNITY COUNICIL 17 JANUARY 1991

### HOW TO RUN FOR A COUNCIL SEAT

The page references given are for the Oct. 11, 1990 version of the proposed Bylaws of the MidCoast Community Council. There will be an election for Council members. At this time we are hoping to be recognized by the San Mateo County Board of Supervisors and to have the election included on the November Ballot.

The council area will include the unicorporated areas of Miramar, El Granada, Princeton, Moss Beach and Montara (p. 50).

There will be a total of seven council members (p.17). One member will be elected from each of five election divisions and two members will be elected at large. The election divisions will be determined by consolidating the eleven election precincts (p. 50). This will be done so that the election divisions are contiguous and approximatedly arithmetically equal (p. 19).

In order to run for a concil seat a candidate must be both an Elector and a Qualified Voter (p.52): that is a person who is a registed voter, entitled to vote in the next election, and registered to vote in one of the election divisions. Each of the five seats to be elected from an election division must be filled by a qualified voter of that election division. Anyone

qualified voter of the area (p.17).

Members of the Community Council will be elected for two year terms and will be staggered. The first two "at large" members will be elected for a period of one year in order to establish the staggered formation (p.19).

Nomination will take place by petition and must be signed by least fifteen (15) qualified voters of the same Election Precinct as the person being nominated. The petition of a qualified voter of the area wishing to run for an "at large" must be signed by one qualified voter from each (11) of the Election Precincts (p.20).

If the MidCoast Community Council is recognized by the San Mateo County Board of Supervisors in time for the November 1991 election, filing for office must be done by mid July or early August. We will have this information for you soon.
