**ARGUMENT IN SUPPORT OF  
MEASURE B**

The San Mateo County Board of Supervisors unanimously voted on May 21, 1991 to allow the voters of the unincorporated Coastside Communities of El Granada, Miramar, Montara, Moss Beach, and Princeton to form the MID-COAST COMMUNITY COUNCIL to advise the Board of Supervisors and their governmental agencies about OUR opinions regarding any issues affecting our lives. Examples of issues that the Municipal Advisory Council (MAC) will want your input on involve current and future planning and zoning issues (residential and commercial development, traffic, parks, water and sewer needs, Cable TV, etc.) and other matters, like off-shore drilling, airport noise, tourism, landfill sites, reapportionment, etc.

**What is a Municipal Advisory Council (MAC)?**

A MAC is a tool that will provide the unincorporated Coastside with seven (7) directly elected voices accountable to you--the voters and residents of the Mid-Coast Community (El Granada, Miramar, Montara, Moss Beach, and Princeton.) The MAC will hold regular public meetings open to all members of the Mid-Coast Area to debate and discuss Coastside issues. The MAC would then pro-actively discuss your position on these issues with the Board of Supervisors in Redwood City--**AND MAKE YOUR VOICE HEARD** by County Officials.

## **What is the Role of the Municipal Advisory Council MAC?**

The MAC would, at no cost to residents, be able to conduct surveys, determine community positions, disseminate information to and from County departments, serve as a liaison for County services, studies and reports and develop community support and/or opposition for County activities, programs and policies. The Municipal Advisory Council would, through active town meetings, serve as a public policy forum for you.

## **Why Create a MAC?**

To insure that your voice is heard--your views are known--your position on crucial issues are represented!

It is also important to have local representation since Redwood City is over 30 miles from our coast and can't be as knowledgeable about our needs and problems as you are. Support for directly elected municipal representation will strengthen community interest and involvement.

## How Can You Help?

By voting YES for Measure B! By directly electing seven (7) of your "Mid-Coast" neighbors to serve as your MAC representative.
