Hi Sam

Thanks for the reminder! Nancy is out of the office until 10/18, but since I've been involved a bit with the MCC subcommittee, I am familiar with the plan and have listed my comments below. I'm also cc-ing Brian Aviles, who is Acting Division Chief in Nancy's absence, and will see if he has any additional feedback to provide.

As you know, we are still in our planning phase for Rancho Corral de Tierra, so we do not have final alignments or locations for our trails and trailheads yet. I can provide you with our understanding and interim plan at this time, and we can discuss what the best way is to represent this.

My understanding of the MCC CA Coastal Trail plan and legend is that there are no actual Coastal Trail segments on Rancho, only mountain trail connections, mountain trails and the parallel trail, correct? Are these spurs and related trails officially part of the Coastal Trail? My comments on specific segments are listed by slide below.

Slide 8 - red trail shown along Cabrillo Farms is currently owned by POST but may be private in the future - may want to add Ownership/Access issues
Slide 12 - red trail shown from south end of Etheldore up to Moss Beach Ranch is what currently exists, but may not be the official mountain connector in the future.
Slide 21 - red trail shown through fallow field -- this is a proposed trailhead and trail connection to Old San Pedro Mountain Road. The location is not confirmed (and may not be for another year or so) and the actual alignment is still uncertain, but would potentially be somewhere within that fallow field.

Slide 21 - legend is unclear. I assume the light blue is intended to be the Mountain Trail and not the Coastal Trail Access? MCC may want to change that color to clarify.

Slide 21 - green trail is listed as Parallel Trail, although there was some discussion at the last MCC CCT meeting about rerouting that along 2nd Street to Le Conte and ending at Farallone View School rather than extending north through Rancho. Given that the parallel trail is intended to serve a transportation function and provide routes for kids to ride between home and school, it seems to make sense to me to route this alignment to the school, not through Rancho.

Slides 25 & 26 - these illustrations and numbers are from the Highway 1 Mobility Study and should be listed as such very clearly. This is not necessarily GGNRA's plan, and as I mentioned above, we are still developing the trailhead and trail concepts.

Slide 30 - As you probably know, Pedro Point is not GGNRA land but may be in the future. The trail is still shown through private land at the northeast end, and at this point may not be a feasible connection. It is still a desired condition, but may want to add information about ownership/access issues here as well. Slide 36 - we assume a signage discussion will follow at some point to determine what is most appropriate for which location. While we recognize the importance of designating the Coastal Trail, the large map signs are out of context with the surrounding area. Any signage on our land will be designed and approved by GGNRA.
