Below are two screen images of the various County-maintained roads (shown with red lines) in the Moss Beach area. The maps are publicly accessible at: <u>https://publicworks.smcgov.org/county-maintained-roads</u>.

The Department is revamping its Pavement Management Program and should have a finalized list in a month or so. The list will provide a general time frame for pavement treatments of all County-maintained roads.

Some of the roads in the area are being addressed as part of this year's Cape Seal Program, locations and type of work attached. The residents have been informed of the work and have also received door hangers by the contractor.

In case folks want to know why some roads are not County-maintained roads, please see the brief explanation below:


Developers building subdivisions are the ones that made the original decision at the development phase to either build roads to County standards or not to County standards. If the roads were built to County standards, they could be dedicated to the County once completed and County will have the option of accepting it or not (if found to be substandard after constructed).


To bring an existing non-County-maintained road into the County system would require the road to be brought up to current standards. It would be a very expensive proposition and, in many cases, not very realistic, since the property owners would have to pay to fully reconstruct the road to current County standards with a minimum of 40' of right-of-way, specific grades for fire engine requirements must be met, etc.


