Dear Members of the Midcoast Community Council,

In preparation for the community meeting tonight, I would like to address one of your concerns prior to the meeting.

It appears that you are suggesting that we should be required to install air filters to help with "odor control". I am happy to inform you that our production of distilled spirits does not generate odors, so hopefully we can clarify this issue even prior to the meeting.

We have been distilling spirits in Princeton for more than three years now, and our neighbors are happy to confirm that no odors are generated by our business. I am attaching two letters from neighbors confirming this. Mr. Lowings is our immediate neighbor here in the same building, and Mr. Watson is a long time resident of Princeton who lives on Harvard Avenue, in very close proximity to our business. Neither of them have ever noticed any odors, and they will be happy to confirm this.

Just like wine making (Trojak Knier Winery at 151 Harvard Avenue) and beer brewing (Hop Dogma Brewery and Half Moon Bay Brewing Company), our processes do not generate odors. It would seem rather arbitrary to require such a thing from us, especially in light of the fact that in three years of engaging in this business activity, no odor has been generated, as confirmed by our neighbors.

I look forward to meeting you tonight. And I again would like to invite you to come visit Half Moon Bay Distillery for a distillery tour and tasting, so you can see what we do. We have regularly scheduled tours on Friday, Saturday and Sunday from 1-4 p.m., and there is no charge for the tour. Let me know if you want to come visit!
