THE KANSAS CITY, KANSAS POLICE DEPARTMENT (KCKPD) HAS A LONG HISTORY OF CORRUPTION AND MISCONDUCT. FOR DECADES, MEMBERS OF THE KCKPD ABUSED THEIR POSITIONS OF POWER AND AUTHORITY TO SOLICIT AND FORCE FABRICATED WITNESS STATEMENTS AND TESTIMONY, PLANT EVIDENCE, FORCE SEXUAL FAVORS, WITHHOLD EXCULPATORY EVIDENCE, CONCEAL THEIR MISCONDUCT AND IGNORE THE WRONGDOING OF OTHERS.

THE KCKPD CONTINUES TO NEGLECT TO HOLD ANY OFFICERS ACCOUNTABLE OR HAVE TRANSPARENCY AROUND CORRUPTION OR MISCONDUCT ISSUES. EVEN THE MOST EGREGIOUS ACCUSATIONS HAVE GONE UNINVESTIGATED. IN 2021, TEAM ROC FILED A PETITION IN WYANDOTTE COUNTY DISTRICT COURT SEEKING RECORDS FROM THE KCKPD TO UNEARTH A HISTORY OF OFFICER MISCONDUCT.

ON SEPTEMBER 16, 2022, FORMER KCK POLICE DETECTIVE ROGER GOLUBSKI WAS INDICTED AND ARRESTED ON FEDERAL CHARGES AFTER DECADES OF ACCUSATIONS OF PREYING UPON AND SEXUALLY ASSAULTING BLACK WOMEN AND CHILDREN DURING CRIMINAL INVESTIGATIONS.

A FEDERAL GRAND JURY INDICTED GOLUBSKI ON SIX COUNTS OF CIVIL RIGHTS VIOLATIONS - HE PLEADED NOT GUILTY ON ALL COUNTS. PROSECUTORS HANDLING THE CASE HAVE ALREADY AMASSED 36,000 PAGES OF EVIDENCE IN THE CASE AGAINST GOLUBSKI.

AND ON NOVEMBER 14, 2022, THE DOJ ANNOUNCED ADDITIONAL INDICTMENTS OF ROGER GOLUBSKI AND THREE OTHERS FOR CONSPIRACY TO HOLD TEENAGERS IN INVOLUNTARY SERVITUDE AND FORCING THEM TO PROVIDE SEXUAL SERVICES. GOLUBSKI IS ALLEGED TO HAVE ACCEPTED MONEY FROM THE MEN, PROVIDED PROTECTION FROM LAW ENFORCEMENT FOR THE CRIMINAL ACTIVITY INCLUDING SEX TRAFFICKING AND FORCIBLY RAPED ONE OF THE TEENAGERS.

GOLUBSKI IS THE SAME DETECTIVE WHO ALLEGEDLY FRAMED LAMONTE MCINTYRE FOR A DOUBLE HOMICIDE IN 1994 BECAUSE HIS MOTHER, ROSIE MCINTYRE, REFUSED THE DETECTIVE'S SEXUAL DEMANDS. LAMONTE WAS WRONGFULLY IMPRISONED FOR 23 YEARS AND RECENTLY SETTLED HIS LAWSUIT IN JUNE OF 2022 AGAINST GOLUBSKI AND OTHER KCKPD OFFICERS.

ROGER GOLUBSKI IS THE FACE OF DEEP-SEATED CORRUPTION AND ABUSE IN KCKPD, BUT HE IS NOT THE ONLY PROBLEM. HIS ARREST IS ONLY THE FIRST STEP IN REPAIRING THREE DECADES OF HARM TO THIS COMMUNITY.

CIVIL RIGHTS AND COMMUNITY GROUPS HAVE REPEATEDLY ASKED FOR INVESTIGATIONS INTO THE DEPARTMENT WHICH PROTECTS AND SHIELDS THESE CRIMES. BECAUSE THE KCKPD FAILS TO HOLD THE PERPETRATORS AND ENABLERS OF THE CRIMES AGAINST THE KCK COMMUNITY ACCOUNTABLE, IT'S UP TO US TO DEMAND JUSTICE. THE UNITED STATES JUSTICE DEPARTMENT MUST OPEN A PATTERN-OR-PRACTICE INVESTIGATION, SIMILAR TO INVESTIGATIONS CONDUCTED IN FERGUSON, MO, LOUISVILLE, KY, AND OTHER CITIES WHERE LONGSTANDING ABUSIVE POLICING HAS OCCURRED.
