Q2 of 2022 has been a bumpy quarter for the FinTech market in Canada. Financial market corrections, crypto company challenges and lower company valuations have led to less optimism in the ecosystem. But then the story in this report might suggest otherwise and so, like most things in the past 2+ years, it's quite hard to predict what might happen in the rest of 2022.

For now, Q2 has seen 3% job growth in new FinTechs, new companies added to the list, impressive funding and new VC fund announcement, and many new partnerships and product launches. In this report, we are pleased to profile the largest sector in Quebec: the 50 PayTechs that employ 19% of the total workforce in Quebec.






FinTechs by Size




