# **Background Information**


Eviction records create life-long barriers to housing security, and disproportionately affect tenants of color. In the last 36 years, well over

1 million eviction cases have been filed in Massachusetts, and their court records are all publicly available online. Currently in MA, tenants are burdened with permanent eviction records even if a landlord filed a case against them that was later resolved, and no eviction occurred. There is currently no process available to either contest or seal a public eviction record. Eviction records don't just affect someone's ability to secure new housing - they can even impact credit and employment. All of this is true even if the tenant wins their case.

The <u>HOMES Act (H.4356)</u> would remedy this by enabling eviction records to be sealed after a length of time determined by the circumstances. No-fault evictions would be able to be sealed immediately after the end of eviction proceedings. Evictions for non-payment of rent would be eligible for sealing either 14 days after satisfying an agreement (such as a payment plan) or after four years, provided that the tenant can show it was a result of economic hardship at the time. For an atfault eviction, a request could be made to seal it after seven years. This law would also allow for housing and credit applicants to answer "no record" if they have an eviction that has already been sealed.

There are ways that H.4356 does not go far enough. For example, rather than requiring tenants to petition the court to have eviction records sealed, we believe that they should be automatically sealed once the tenant has either won or come to an agreement with the landlord such as a payment plan. We are following the lead of grassroots housing advocates and organizers by supporting the bill while also calling for an amendment that would add automatic sealing in certain cases.

# **ACTION TIME**

### STATUS OF PROPOSED BILL

**H. 4356** has been reported out favorably from the Joint Committee on the Judiciary. This is the first bill in our Season of Advocacy that has made it past that stage!

Additionally, Governor Healey's proposed housing bond bill, known as the **Affordable Homes Act (H. 4138)**, includes a weaker version of eviction sealing (Section 47). Since a housing bond bill MUST be passed each legislative session, it is more likely that eviction sealing will pass as part of this larger package. In this case, we'll focus our advocacy efforts on improving the eviction sealing sections of the Affordable Homes Act. **The Pass the HOMES Act campaign site has a detailed fact sheet** for more information.

### **OUR FOCUS:**

Getting our own legislators to support the HOMES act (H.4356) and the Housing Bond Bill (H. 4138) when it comes up for a vote AND ask them to advocate for an amendment that has automatic sealing of dismissals, tenantwon cases, and no-fault evictions.

Ask the Joint Committee on Bonding to substitute the HOMES Act/H.4356 for Section 47 of the Bond Bill/H.4138 with automatic sealing added.

## **SPECIAL NOTE:**

Unlike the other bills we are trying to get out of committee, these do not have an upcoming reporting deadline. Please keep working on these bills through the rest of the legislative season (until June/July).

#### SAMPLE CALL SCRIPT FOR COMMITTEE CHAIRS AND MEMBERS:

"Hello! My name is [first and last name] and I am calling [committee member name] to urge [her/him] to move the Affordable Homes Act (H. 4138) to a full floor vote. It is important to me that all of the funding for public housing and affordable housing do not get cut at all, and I also believe it needs two amendments. The first is to replace the eviction sealing section (Section 47) with the text of the HOMES Act (H.4356) which is stronger. The second is to further improve the eviction sealing section by adding an amendment that has automatic eviction sealing of dismissals, tenant-won cases, and no-fault evictions."

Dear Chair Kennedy, Chair Finn, and Committee Members,

I'm **[Your Name]**, a resident of **[Your City/Town]**, advocating for the Affordable Homes Act (H.4138), specifically urging for its advancement to the house floor without reductions in proposed funding.

While appreciating the bill's overall strength, I wish to highlight the need for enhancements in the eviction sealing provision (section 47). Lengthy wait periods and a requirement to file sealing requests with the court create obstacles that many families may struggle to overcome, perpetuating housing instability.

To address this, I urge the Joint Committee on Bonding to consider the following amendments to H.4138:

- 1. Automatic sealing of eviction records in cases dismissed, won by the tenant, or involving no-fault evictions.
- 2.Adoption of the stronger eviction sealing language from the HOMES Act (H.4356) in place of Section 47.

These changes align with the eviction sealing's purpose to facilitate housing access and alleviate administrative burdens on the court.




