Championing Justice for People with Disabilities & Ensuring Access for All

Legal Services is dedicated to advocating for people with disabilities, ensuring their safety and well-being by helping them obtain the benefits they are entitled to.

Hope for One Family



Olga and her family struggle daily to provide the best care possible for her brother, Ulises. Born with developmental disabilities, Ulises recently turned 49 and is now bedbound in a semi-comatose state. Faced with

numerous challenges, including a reduction in Medicaid services, the citizenship application process, and obtaining a state card, they turned to Legal Services for help.

Legal Services Attorney Jocelyn Armand developed a comprehensive approach to address their legal hurdles and meet Ulises' specific needs. Jocelyn filed an appeal challenging the reduction of nursing services by Medicaid, successfully ensuring Ulises continues to receive 24/7 home care and enabling Ulises to maintain access to the care he needs to survive.

Additionally, we represented Ulises through the naturalization process, obtaining waivers for the required exam and oath ceremony, and securing a disability accom-

modation for an in-home visit in lieu of the traditional interview process. His family, who left communist Cuba for a better life, achieved their dream of having him become a U.S. citizen. Additionally, his naturalization ensures continued access to life saving care and other benefits without fear of losing eligibility.

Our advocacy extended further. Ulises also needed a Florida ID to access services,

but his family was unable to obtain one on his behalf. In today's day and age, we all understand the importance of having an identity document in everyday life. Due to his inability to leave home, this simple task was challening. After the Florida Department of Highway Safety

and Motor Vehicles (FLHSMV) denied our request for a reasonable accommodation, we sent an ADA demand letter based on discrimination against persons with disabilities. Subsequently, FLHSMV coordinated a home visit allowing Ulises to obtain a Florida ID.

Thanks to Legal Services, this family's journey transformed from one of uncertainty to one of hope and empowerment. By addressing their legal needs, we resolved immediate challenges and laid the foundation for a brighter future for Ulises and his entire family.

Systemic Impact

People with disabilities like Ulises face considerable systemic barriers

to obtaining a state ID. Our attorneys ensure state programs are administered with fairness and due process so that everyone, including those with disabilities, has an equal opportunity

to benefit from their services. Through our advocacy in this case, we ensured that the FLHSMV adopted new internal policies and procedures, making it possible for thousands of Floridians with disabilities to obtain an ID.



From the Chief Executive Officer Monica Vigues-Pitan It has been a productive year as we work to ensure a fair and equitable legal process by supporting our clients individually and advocating for systemic change.

Newly Approved Form for Pro Se Tenants – Our Tenants' Rights team has achieved an impressive milestone. Many people facing eviction represent themselves in court. Since the Miami-Dade Clerk of Court's website only had forms to help landlords, back in 2015 we asked about the inclusion of our eviction materials. Our attorneys were advised that the Clerk could only publish forms approved by the Florida Bar and the Florida Supreme Court, but none existed. Over the years, we advocated to the Florida Supreme Court, the Office of State Court Administrator, and the Florida Bar for a form tenants could use when answering an eviction. During this time, one of our attorneys began serving on the Bar's Rules Committee. In 2019, the Bar's Civil Procedure Rules Committee recommended a form allowing tenants to select defenses and file motions regarding rent disputes. This past June, the Florida Supreme Court approved Form 1.947(b) - Answer - Residential Eviction. Clerks statewide are now publishing the form, helping tenants respond to evictions and present their defenses. After more than a decade of advocacy, we are proud of this victory that increases access to justice for self-represented litigants.

I have had the pleasure of participating in the work of Legal Services of Greater Miami for twenty years as a pro-bono attorney, Board member and officer, and member of the Foundation. Legal Services is defined by its laser-focus on its mission: helping those who can't afford private attorneys with important legal problems such as eviction, foreclosure, and access to government benefits. As documented by a study, every dollar spent on Legal Services generates seven dollars of income for the community as a whole. That's the kind of multiplier we can be proud of!

Ensuring Continuity of Healthcare Through Medical-Legal Partnership

In her early 50s and dealing with chronic medical conditions, including thyroid cancer, Maria was scared when she learned her Medicaid benefits would end. Left without essential healthcare coverage to obtain immediate care for her conditions, Maria was

referred to our Medical-Legal Partnership. After consulting with her, Legal Services Senior Staff Attorney Daniel Rowinsky discovered the agency that administers the Medicaid program erroneously terminated her coverage Medicaid based on inaccurate income information.



Legal Services filed an appeal and successfully advocated for her Medicaid

benefits to be reinstated retroactively. As a result, she would be able to continue her treatments and avoid any medical debt. Additionally, Legal Services provided critical legal advice regarding her Social Security Disability Insurance (SSDI)



claim that had been closed a few years prior for missing a hearing. Moreover, we referred Maria to a local partner for assistance with recertifying her Medicaid and food assistance (SNAP) claims. This holistic approach not only reinstated Maria's healthcare coverage, but also set her on a path to secure additional support and financial stability.

Tenant Restored to His Rightful Home, Thanks to Our Partnership with Wells Fargo

In partnership with the Wells Fargo Foundation, Legal Services has helped thousands of people facing eviction or the threat of eviction remain in their homes. Mr. Hadley's case exemplifies that no matter the uniqueness of the circumstances, our partnership helps tenants assert their rights and protect them from eviction.

At age 60, Mr. Hadley took in his brother and family to help them avoid homelessness. He is no stranger to being a caretaker to his family as he cares for his aging mother alone.



After witnessing his brother's abuse of their mother, Mr. Hadley asked his brother to leave. **His brother refused**. Police

were called after a tense argument ensued, and Mr. Hadley was arrested despite having suffered a head injury. During the next few months while Mr. Hadley was held in jail unable to post bail, his brother, along with his family, took control of his apartment, and threatened Mr. Hadley's lease and Section 8 participation by not paying rent. Once released, Mr. Hadley found that he could not return to his own home without violating the automatic protective order against his brother (the criminal charges were eventually dismissed).



Mr. Hadley was forced to stay with family and sought the assistance of Legal Services to get his home back. Legal Services Attorney Alexandra Lasher successfully filed an unlawful detainer action to evict the brother proving he had no rights to the apartment. The judge issued a favorable judgment, restoring legal possession of the property to Mr. Hadley.

Additionally, we negotiated an expedited amendment to the protective order, allowing Mr. Hadley to finally return home, resume everyday life, and continue caring for his mother. Through our advocacy, we ensured Mr. Hadley's housing rights and stability were protected.

Pro Bono Attorney Wins Appeal for Nonprofit to Develop Affordable Housing & Maximize Impact

Little Haiti Housing Association (LHHA), a nonprofit affordable housing developer, owned property in the Little Haiti neighborhood on which it intended to develop affordable housing. The property was encumbered by an improperly created conservation easement which prohibited any construction or development on the property. The property was devoid of any special ecological, geological or environmental factors which conservation easements are designed to protect. Instead, the easement appeared to be a sham, designed to cloud title which violated Florida's public policy in favor of the marketability of real property, free of unreasonable restraints on transfer.

In 2016, Legal Services co-counseled with pro bono attorney Michael Whitt and filed a quiet title action to remove the conservation easement. In October 2022, the trial court entered summary judgment in favor of LHHA. The party asserting the conservation easement appealed the judgment to the 3rd DCA. Michael Whitt, now with the firm of Hahn Loeser & Parks, in Fort Myers, again co-counseled with Legal Services to represent LHHA in the appeal. The 3rd DCA affirmed the decision in June 2024, and LHHA is now free to pursue its mission of constructing much-needed affordable housing on the property.


