If an exact replacement is no longer available, we will it substitute with a product of the equal or greater value than the original purchase.

MANTELS ARE INDIVIDUALLY CAST, AND HAND-PAINTED. Mantel color and dimensions can vary slightly from samples and published measurements.

WARRANTY LIMITATIONS apply if the item has been subjected to neglect, misuse, alteration, unauthorized repairs, relocation, dents, dings, scratches, incorrect applications, Acts of God, and all other uncontrollable events, which are not covered by this warranty.

Any minor discrepancies that may occur during, or after the warranty period, ARE NOT typically considered to be a warranty issue. For this reason, we include touch-up kits for all finishes, to allow you to make these repairs when necessary.
