1. Welcome/Introductions (Sean Chambers - 5 min.)

Meeting began at 4:08 pm and a quorum was established.

SPBRT welcomed new members Commissioner Adam Gates as the Yuma County roundtable appointment and Julia Gallucci with Colorado Springs Utilities as the El Paso County Municipality representative.

4. Public Comment (3 min.)

Update was provided on the Aerial Snow Observation (ASO) grant which is up for CWCB approval. The first flight is scheduled in April with a second flight in May. There was discussion on funding the project. The SPBRT is eager to see results from the ASO pilot work. Please bring the logo to the Statewide PEPO meeting scheduled for Friday. It would be important to connect PEPO to the IBCC. It would be good for all RTs to use the same logo. Accounts of recent presentations and booth presentations were provided. Colorado WaterWise is hosting a workshop on their BMPs. PEPO will be supporting this event.

3. M&I Committee (Jim Hall – 5 min.) (*No Meeting Summary*)

The Committee met on March 7th. The main topic was the RT initiated landscape project and moving toward climate resilient landscapes. The Committee is putting together recommendations. They are refining the scope then plan to send out an RFP. It would be good to communicate this effort to the Urban Landscape Conservation Task Force appointed by CWCB and initiated by the Governor, <https://dnr.colorado.gov/press-release/colorado-establishes-urban-landscape-water-conservation-task-force>. The project may be a good fit for the PEPO statewide funding with a June 15th grant deadline.

4. Colorado River/Demand Management (Sean Chambers & Kyle Whitaker – 10 min.)

7. State Legislative Update (Sean Chambers – 10 min.)

1. [Colorado Water Congress State Affairs Committee 2023 Tracking Sheet](#)

The tracking sheet is intended to facilitate conversation on legislation of interest to the members. There is notable stream restoration legislation. Stream restoration and water rights concerns is included in this current legislation. There was discussion on projects that effect the timing of water to downstream users. There is concern that there has not been enough research on the water timing of these projects, making it difficult for water rights users to accept. This is being addressed on a project by project basis. The stream restoration bill is in a work group and has not come out yet. The work group is considering how to manage the risks and take into account the many perspectives. The RT does not wish to take a position on any legislation. It does want to encourage dialogue on proposed legislation. There was consensus in the group for the Chair to bring this discussion to the Director Sakata. Two points of importance to convey to the Director are protection of water rights and mountain community water and wildfire concerns.

- a. The proposed stream restoration bill concept highlights a natural tension between the important protection of vested water rights and an honest desire to support efforts to undertake stream restoration and watershed health activities.
- b. The SPBRT membership recognize that stream restoration is important work, but generally desire additional stakeholder engagement discussions and opportunities to advise DNR on necessary controls or limitations that would protect the vested water rights and support SEO administration. Ideas included -
 1. Requirements for applicants to analyze, calculate, and report any increases to exposed surface water through the restoration project.
 2. Limitations to the number of projects in any given five-mile reach of a stream or some metric that could prevent a proliferation of projects that would impact water rights.
 3. Post project restoration reporting.

There is an oil and gas bill that asks to limit the use of fresh water to the oil and gas industry that may be of interest to members, HB23-1242.

It was a short meeting. They are still working on the IBCC objectives. Many IBCC members are reporting that their RTs participating numbers are at pre-covid levels. Dan Gibbs challenged RTs to identify a significant project to be implemented. The other RTs are reporting progress on this effort.
