PEPO is participating in the North Front Range Water Quality Planning Association (NFRWQPA) meetings to identify stakeholder processes already in place. NFRWQPA is working on developing an EPA 9-point watershed plan.

State has formed a Colorado River Drought Task Force as directed by SB23-295 and it is expected that task force meetings will be scheduled. . It was noted that the bill creating the task force was controversial in some stakeholder communities, it has been created to develop recommendations for state legislation that provides additional tools for the CWCB Board.
