

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.thehopedocs.org, and FEMMEmpowerment and Advocacy, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to FEMMEmpowerment and Advocacy, LLC include www.thehopedocs.org and The HOPE Doctors. The The HOPE Doctors website is a Ecommerce. Online education and information. Pelvic floor education. Community. Product building and selling. site. By using the The HOPE Doctors website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The HOPE Doctors may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase The HOPE Doctors's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through The HOPE Doctors's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

The HOPE Doctors collects and uses your personal information to operate and deliver the services you have requested.

The HOPE Doctors may also use your personally identifiable information to inform you of other products or services available from The HOPE Doctors and its affiliates.

Sharing Information with Third Parties

The HOPE Doctors does not sell, rent or lease its customer lists to third parties.

The HOPE Doctors may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to The HOPE Doctors, and they are required to maintain the confidentiality of your information.

The HOPE Doctors may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on The HOPE Doctors or the site; (b) protect and defend the rights or property of The HOPE Doctors; and/or (c) act under exigent circumstances to protect the personal safety of users of The HOPE Doctors, or the public.

Tracking User Behavior

Automatically Collected Information

Use of Cookies

- SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our
