•Information Packet will include specific information on parking pass, set-up, booth assignment, etc. This document will be sent out weeks prior to the event date. •It is the responsibility of the vendor/exhibitor to obtain liability insurance valid through set up and take down of the expo materials.

•All Federal, State, County & City laws pertaining to fire & safety must be adhered to. (No open flames or lit candles are allowed as per City).

•Exhibitors are responsible for meeting all City/County/State resale, licensing, & Health Department requirements.

•We reserve the right to refuse a vendor/exhibitor.

Cancellation Policy: In the event that an outside force beyond the control of A GOOD RUN, such as war, fire, or act of God, that

prevents the event from taking place, we reserve the right to retain a Vendor and Exhibitor payments to cover expenses. A full credit will be applied to future IPA10K or other event of A Good Run, LLC.
